ORDER



UPON the application of Alec David Pillmoor of Baker Tilly Creditor Services LLP and RSM Restructuring Advisory LLP (RSM)

AND UPON READING the witness statements of Alec David Pillmoor dated 17 November 2017, and William Duncan dated 16 November 2017

IT IS ORDERED that

1. The proceedings listed in the Schedule to this Order be transferred to the High Court of Justice, Business and Property Court in Leeds, Insolvency and Companies List, solely for the purpose of the determination and disposal of this Application upon which they be transferred back to the court or hearing centre from which they were transferred.
2. William Duncan be removed from office as Liquidator, Supervisor or Trustee (as the case may be) of the estates listed in the Schedule to this Order and be replaced by the individuals named in the said Schedule as set out therein with immediate effect.
3. William Duncan be removed and replaced, as set out in the Schedule, in each such case with immediate effect, without being required to (i) apply to the Secretary of State for release or discharge as appropriate pursuant to s299(3)(b), s173(2)(b) and s174(4)(b) of the Insolvency Act 1986 as the case may be, or (ii) file a receipts and payment account.
4. In any matter where more than one person is by virtue of this Order appointed as the office-holder in relation to an estate, the functions of the office-holders may be exercised by any or all of the persons appointed.
5. William Duncan be discharged from liability as office-holder 21 days after the publication of a notice in the Gazette as provided for by paragraph 6 of this Order.
6. The creditors in each of the cases listed in the Schedule shall be notified of this order by way of

one composite notice to be published in the Gazette within 14 days of receipt of the sealed Order and to file any appropriate notices in respect of the removal of William Duncan and the appointment of the new office-holders appointed pursuant to paragraphs 2 and 3 of this Order (the New Office-Holders) with the Registrar of Companies and the Secretary of State for Business Innovation and Skills (Insolvency Service) as appropriate.

7. Subject to paragraph 11 below, in the event that, as a result of the implementation of the Order RSM incurs any additional cost in respect of the administration of those estates where William Duncan was the office-holder (that is to say over and above those costs incurred in the ordinary course of the administration of those estates), those costs shall be borne by RSM and shall not be charged as an expense of the administration of those estates.
8. Nothing contained in paragraphs 7 or 11 shall prejudice the Applicant, the Respondents or the New Office-Holders from:
 - 8.1 Charging to each individual estate the cost of obtaining an Insolvency Practitioner's licence bond in respect of that estate; and
 - 8.2 Apportioning between the said estates equally the cost of the composite Gazette notice to be placed under paragraph 6 above.
9. Without incurring any additional expense for any of the said estates, the relevant Applicant, Respondents or New Office-Holders shall notify each creditor of this Application and this Order by way of notice in the next routine report that shall be due to the creditors of each estate, such notice to contain the following matters:
 - 9.1 An explanation of the effect of the Order,
 - 9.2 Express reference to the liberty to apply contained in paragraph 10 below;
 - 9.3 In the case of Liquidations and Bankruptcies, where Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that any information which would otherwise be required to be provided under rule 6.25(5), rule 7.61(5) or rule 10.77(5) (as the case may be) of the Insolvency Rules 2016 has not already been provided as part of the report, it is open to that committee to require the relevant Applicant, Respondent or New Office-Holder to provide an account of the administration of the estate, including a summary of receipts and payments;
 - 9.4 In the case of Liquidations and Bankruptcies where no Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that such
