### **Director's Report**

At the last report BISA had experienced a year of success with regard to the court hire - with the year of 2020 seeing Covid-19 hit the UK opportunity to continue this success was limited.

Following from the success of 2019 and being unknowing of what faced us, in January BISA was able to support the commencement of a village sports group for women and also to replace the 5-a-side football goals. The 2019 court hire funds enabled these investments - although I'm pleased to say that despite minimal takings the 2020 hire did eventually cover the investments.

BISA decided at the 2020 AGM to suspend all charges for the courts between the start of lockdown and the end of the year in order to support any local residents to get outside safely as restrictions allowed by booking slots on the courts with no charge to be sure of group numbers.

Fundraising from the early part of the year for the pavilion project has also been reflected in the accounts.

Badminton surplus from the early part of the year was credited - as with court hire when it was possible to play badminton during the year no charges were made for players with the club covering hall hire.

Finally - and as with previous years - a single deposit from an unknown source has been received. This has been saved in full as with previous deposits of this kind.
