Copyright Security Agreement

THIS COPYRIGHT SECURITY AGREEMENT, dated as of June 24, 2020 (this "Security Agreement"), is made by the Person listed on the signature pages hereof (the "Grantor"), in favor of TRUIST BANK (as successor-in-interest to Suntrust Bank), as administrative agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") for the Secured Parties (as defined in the Guaranty and Security Agreement referred to below).

WHEREAS, DOWNTOWN COPYRIGHT MANAGEMENT (IOM) LIMITED, a company limited by shares with number 014022V and having its registered office at Fort Anne, Douglas, Isle of Man, IM1 5PD ("SPV(IOM)"), DOWNTOWN COPYRIGHT MANAGEMENT LLC, a Delaware limited liability company ("SPV(U.S.)") and DOWNTOWN COPYRIGHT MANAGEMENT UK LIMITED, a private limited company registered in England and Wales ("SPV(UK)", and together with SPV(IOM) and SPV(U.S.), each a "Borrower" and collectively the "Borrowers"), the lenders from time to time parties thereto (the "Lenders"), and the Administrative Agent have entered into that certain Amended and Restated Revolving Credit and Term Loan Agreement, dated as of August 10, 2018 (as amended, restated, supplemented, replaced, increased, refinanced or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, the Grantor has entered into that certain Amended and Restated Guaranty and Security Agreement, dated as of August 10, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement"), in favor of the Administrative Agent for the benefit of the Secured Parties; and

WHEREAS, the Guaranty and Security Agreement requires the Grantor to execute and deliver this Security Agreement;

NOW, THEREFORE, in consideration of the premises and in order to ensure compliance with the Credit Agreement, the Grantor hereby agrees as follows:

SECTION 1. <u>Defined Terms</u>. Unless otherwise defined herein, terms defined in the Guaranty and Security Agreement and used herein shall have the meanings assigned to such terms in the Guaranty and Security Agreement. The rules of construction specified in Section 1.3 of the Credit Agreement also apply to this Agreement, mutatis mutandis.

SECTION 2. Grant of Security Interest in Copyright Collateral. The Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of the Grantor, hereby mortgages, pledges and hypothecates to the Administrative Agent for the benefit of the Secured Parties, and grants to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the following assets and properties now owned or at any time hereafter acquired by the Grantor or in which the Grantor now has or at any time in the future may acquire any right, title or interest in all of the following items or types of property (being herein collectively referred to as the "Copyright Collateral"):

- (i) all of its Copyrights and all Copyright Licenses providing for the grant by or to the Grantor of any right under any Copyright, including, without limitation, those referred to on Schedules I hereto;
 - (ii) all renewals, reversions and extensions of the foregoing; and
- (iii) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.
- **SECTION 3.** Guaranty and Security Agreement. The security interest granted pursuant to this Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the Guaranty and Security Agreement, and the Grantor hereby acknowledges and agrees that the rights and remedies of the Administrative Agent with respect to the security interest in the Copyright Collateral made and granted hereby are more fully set forth in the Guaranty and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
- Agent notice on no less than a quarterly basis in writing of any additional United States copyright registrations or applications therefor after the date hereof. The Grantor hereby authorizes the Administrative Agent unilaterally to modify this Agreement by amending <u>Schedule I</u> to include (a) any future United States registered copyrights or applications therefor of the Grantor and (b) any future United States unregistered copyrights therefor that become known to the Administrative Agent. Notwithstanding the foregoing, no failure to so modify this Copyright Security Agreement or amend <u>Schedule I</u> shall in any way affect, invalidate or detract from the Administrative Agent's continuing security interest in all Copyright Collateral, whether or not listed on <u>Schedule I</u>.
- **SECTION 5.** Counterparts. This Security Agreement may be executed by one or more parties to this Security Agreement on any number of separate counterparts, and all of said counterparts taken together shall be deemed to constitute one and the same instrument. Delivery of an executed counterpart to this Security Agreement by facsimile transmission or by electronic mail in pdf format shall be as effective as delivery of a manually executed counterpart hereof.
- **SECTION 6.** Governing Law. This Security Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
