Principal activities

The principal activities of the company are to manage property, and to promote training, skill development and encourage employment opportunities

The loss for the year before taxation amounted to £318,790 (2006 profit £9,222) The loss for the year after taxation amounted to £325,790 (2006 profit £5,222) which has been transferred to reserves

Capital funding

Lancashire Technology Centre Limited is a company limited by guarantee, therefore, does not have a share capital. Its funding is provided by way of capital contribution from Burnley Borough Council and a loan from Lancashire County Developments Limited

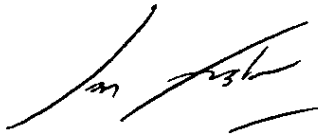

We have audited the financial statements of Lancashire Technology Centre Limited for the year ended 31 March 2007 which comprise the profit and loss account, the balance sheet and notes 1 to 13. Principal accounting policies

The financial statements have been prepared in accordance with applicable United Kingdom accounting standards and under the historical cost convention

Operating income

Operating income represents rental and service income charged to third parties exclusive of value added tax which is recognised in the period to which they relate

Fixed assets

Tangible fixed assets are stated at cost less accumulated depreciation and any provision for impairment

Depreciation is provided on all tangible fixed assets at rates calculated to write off the cost less the estimated residual value of each asset, over their expected useful lives as follows

Deferred taxation

Deferred tax is recognised on all timing differences where the transactions or events that give the company an obligation to pay more tax in the future, or a right to pay less tax in the future, have occurred by the balance sheet date. Deferred tax assets are recognised when it is more likely than not that they will be recovered. Deferred tax is measured using rates of tax that have been enacted or substantively enacted by the balance sheet date

Investment properties

In accordance with Statement of Standard Accounting Practice No 19, certain of the company's properties are held for long-term investment and are included in the balance sheet at their open market values. The surplus(es) or deficit(s) on revaluation of such properties are transferred to the investment property revaluation reserve. Depreciation is not provided in respect of freehold investment properties. Leasehold investment properties are not amortised where the unexpired term is over twenty years

This policy represents a departure from statutory accounting principles, which require depreciation to be provided on all fixed assets. The directors consider that this policy is necessary in order that the financial statements may give a true and fair view, because current values and changes in current values are of prime importance rather than the calculation of systematic annual depreciation. Depreciation is only one of many factors reflected in the valuation and the amount which might otherwise have been shown cannot be separately identified or quantified

12 Constitution

The company is limited by guarantee. At 31 March 2007, there were 3 members (2006 4), each of whom on winding up has undertaken to contribute an amount not exceeding £1. The members represent the interests of the following organisations, Burnley Borough Council, Burnley College, and Lancashire County Developments Limited, all of which contribute to the achievement of the company's objectives and activities.

On the 25 April 2006 Northern Technologies ceased to be a member and are therefore, from that date, was no longer represented on the Board. The remaining members now have equal membership.

13 Related parties

Sales transactions with Burnley College (a member of the company) amounted to £55,672 (2006 £83,617). Purchases from this related party were £9,261 (2006 £5,496). The amount owed by this related party at 31 March 2007 was £23,190 (2006 £28,424). The amount owed to this related party was £nil (2006 £5,496).

Sales transactions with Northern Technologies Limited (a former member of the company) amounted to £133,953 (2006 £121,929). Purchases from this related party were £2,914 (2006 £6,468). The amount owed by this related party at 31 March 2007 was £29,195 (2006 £47,376). The amount owed to this related party was £nil (2006 £4,302).

Sales transactions with Burnley Borough Council (a member of the company) amounted to £29,077 (2006 £28,557). Purchases from this related party were £73,448 (2006 £2,853). The amount owed by this related party at 31 March 2007 was £1,863 (2006 £20,142). The amount owed to this related party was £nil (2006 £nil).

Sales transactions with Lancashire County Developments Limited (a member of the company) amounted to £165 (2006 £169). Purchases from this related party were £27,043 (2006 £54,896). The amount owed by this related party at 31 March 2007 was £nil (2006 £nil). The amount owed to this related party was £33,744 (2006 £17,269).

Purchases from Lancashire County Council were £49,454 (2006 £41,089). The amount owed to this related party at 31 March 2007 was £4,702 (2006 £26,778).

At 31 March 2007, Lancashire County Developments Limited provided funding to the company by way of a loan of £255,550 (2006 £255,550). At the date of these accounts, there are no fixed terms for repayment.
