

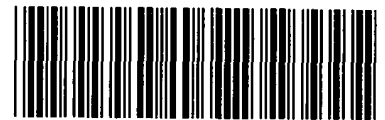

The trustees present their report and the unaudited financial statements of the charity for the year ended 31 March 2021

INTRODUCTION

GRASSROOTS (CARDIFF) LIMITED is a registered charity limited by guarantee.

LEGAL STATUS

Registered Charity number 1110186

Company registered Number 5038314

OBJECTIVES OF THE CHARITY

The company is a registered charity the liability of whose members is limited by guarantee. It is governed by a memorandum and articles of association. The principal object of the company is to provide support, information and guidance to socio-economically deprived young people aged sixteen to twenty-five years old.

The charity is organised so that the Board meet regularly to manage its affairs. There are full time employees, who manage the day to day administration of the charity and further its objectives.

DEVELOPMENTS, ACTIVITIES AND ACHIEVEMENTS REVIEW

The board considers that the performance of the Charity this year has been good. Regular meetings have been held by the Trustees and they have been informed about the projects delivered by the organisation and its on-going financial position.

The COVID pandemic and lockdown restrictions have had an impact on service delivery. Services have been delivered online and in outdoor spaces when appropriate. Issues centring on homelessness and precarious housing situations continue to be a challenge in addition to supporting young parents and those experiencing relationships issues in addition to promoting optimism and resilience to the young people using the Project.

Activities have been undertaken safely within Covid guidelines. These have included outdoor meetings with groups of young people including the Baby Roots Parents Group band the Aspie Roots Project. We have further developed partnerships with Challenge Wales offering sailing activities to young people and Into Work Services to support young people into paid employment and volunteering opportunities. Grassroots has continued to offer emergency food parcels to vulnerable young people and their families using food donated by local supermarkets. Most excitingly young people are developing a Community Wildlife Garden using space within Cardiff Castle and this has had a positive impact on the emotional health and wellbeing of young people during the on-going challenges presented by the pandemic

Membership of the Board of Trustees will be reviewed at the next Annual General Meeting where those wishing to step down can, and new trustees can be appointed.

RISKS POLICY

The major risk identified by the trustees is the loss of core funding from the City of Cardiff Youth Service, failure to gain external funding and charitable donations, especially in the current economic climate.

I report on the accounts of the charity for the year ended 31 March 2021 set out on pages 4 to 10

Respective Responsibilities of Trustees and Examiner

The charity's trustees (who are also directors of GRASSROOTS (CARDIFF) LIMITED for the purpose of company law) are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 and that an independent examination is needed.



NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2021

1. Accounting policies

Statement of compliance - These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

Cash flow statement – The directors have taken advantage of the exemption in Financial Reporting Standard No. 1 from including a cash flow statement on the grounds that the company is small.

Incoming resources – All incoming resources are recognised when receivable and when all conditions for receipt have been met. No expenditure has been netted off incoming resources in the Statement of Financial Activities.

Resources expended – costs of activities in furtherance of the charity's objects represent those costs incurred directly in connection with charitable activities. Management and administration costs comprise costs associated with managing and administering the charity and include an appropriate apportionment of overheads.

Funds structure – Unrestricted funds are those available for general use by the charity. Designated funds are unrestricted funds which have been set aside by the Trustees for specific purposes. Restricted funds are those where imposed restrictions have been placed on their use.
