The trustees present their report and the unaudited financial statements of the charity for the year ended 31 March 2023.

INTRODUCTION

GRASSROOTS (CARDIFF) LIMITED is a registered charity limited by guarantee.

OBJECTIVES OF THE CHARITY

The company is a registered charity the liability of whose members is limited by guarantee. It is governed by a memorandum and articles of association. The principal object of the company is to provide support, information and guidance to socio-economically deprived young people aged sixteen to twenty-five years old.

The charity is organised so that the Board meet regularly to manage its affairs. There are full time employees, who manage the day to day administration of the charity and further its objectives.

DEVELOPMENTS, ACTIVITIES AND ACHIEVEMENTS REVIEW

It is with great sadness to note that Dan Wilson, the Company Secretary for the Grassroots Charity passed away on the 27 December 22. Dan was a much respected and admired lead Youth Worker in Grassroots. His focus was very much to support the young people that come to Grassroots for activities and support in their lives. Dan is missed and we extend our condolences to his family.

The Charity has been in a process of considering its future and its longer-term relationship with Cardiff County Council who owns the building that the Charity has operated from. Regular meetings have been held by the Trustees and they have been informed about the projects delivered by the organisation and its on-going financial position.

The COVID pandemic and lockdown restrictions have had a long term impact on service delivery, which were delivered directly to the County Council. Services have been delivered online and in outdoor spaces when appropriate. Issues centring on homelessness and precarious housing situations continue to be a challenge in addition to supporting young parents and those experiencing relationships issues in addition to promoting optimism and resilience to the young people using the Project.

Membership of the Board of Trustees will be reviewed at the next Annual General Meeting where those wishing to step down can, and new trustees can be appointed.

RISKS POLICY

The major risk identified by the trustees is the loss of partnership support from the City of Cardiff Youth Service, failure to gain external funding and charitable donations, especially in the current economic climate

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2023

1. Accounting policies

Statement of compliance -These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

Cash flow statement – The directors have taken advantage of the exemption in Financial Reporting Standard No. 1 from including a cash flow statement on the grounds that the company is small.

Incoming resources – All incoming resources are recognised when receivable and when all conditions for receipt have been met. No expenditure has been netted off incoming resources in the Statement of Financial Activities.

Resources expended – costs of activities in furtherance of the charity's objects represent those costs incurred directly in connection with charitable activities. Management and administration costs comprise costs associated with managing and administering the charity and include an appropriate apportionment of overheads.

Funds structure – Unrestricted funds are those available for general use by the charity. Designated funds are unrestricted funds which have been set aside by the Trustees for specific purposes. Restricted funds are those where imposed restrictions have been placed on their use.
