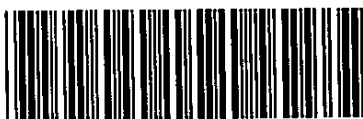

DRAFT ORDER

UPON the Application dated 7th April 2011 ("the Application")

AND UPON reading the papers recorded in the Court file as having been read

IT IS ORDERED THAT –

- 1 In respect of the relevant company voluntary arrangement, administration, liquidation, individual voluntary arrangements and bankruptcy appointments identified in the Schedule annexed hereto ("the Schedule") as being the subject of proceedings not already within the jurisdiction of the High Court in London, these proceedings be transferred to the High Court in London, Chancery Division, solely for the purpose of making the orders contained in the paragraphs below and thereafter be transferred back to the relevant County Court
- 2 In relation to all the company voluntary arrangement appointments held by the First Respondent solely and jointly with others, the First Respondent be removed from office and Nigel Ian Fox and Alexander Kinninmonth be appointed in his place, as detailed in the Schedule
- 3 In relation to all the administration, members' voluntary liquidation, creditors' voluntary liquidation and compulsory liquidation appointments held by the First Respondent solely and jointly with others, the First Respondent be removed from office and Nigel Ian Fox, Trevor Binyon, Alexander Kinninmonth and Peter Hughes-Holland be appointed in his place, as detailed in this Schedule
- 4 In relation to all the individual voluntary arrangement appointments held by the First Respondent solely and jointly with others, the First Respondent be removed from office and Alexander Kinninmonth be appointed in his place, as detailed in the Schedule
- 5 In relation to the bankruptcy of David Paul Oulton (case number 386 of 2005 in the Coventry County Court), the First Respondent be removed from office as the sole trustee in bankruptcy and Ian Cadlock and Nigel Ian Fox be appointed as joint trustees in bankruptcy in his place, as detailed in the Schedule
- 6 In relation to all bankruptcy appointments save for the appointment referred to in paragraph 5 above, held by the First Respondent whether solely and jointly with others, the First Respondent be removed from office and Nigel Ian Fox and Alexander Kinninmonth be appointed in his place, as detailed in the Schedule
- 7 The effect of the orders referred to at paragraphs 2 to 6 above is summarised by reference to the initials of the incoming Office Holders set out in the Schedule
- 8 The Applicants shall at the first opportunity to do so, and in any event within 3 months of the date of this order, publish in the London Gazette, one composite notice in relation to each of

the estates containing notification of the following matters -

- (i) The removal of the First Respondent and the appointment of his replacement(s)
- (ii) That creditors/members are at liberty to apply within 28 days of the date of the advertisement, to vary or discharge the order made
- (iii) In the case of liquidations, where a liquidation or creditors' committee has been appointed, an explanation that it is open to the committee to require the Applicant(s) appointed or Office Holder remaining in office to provide an account of the administration of the estate pursuant to Rule 4 108(3) of the Insolvency Rules 1986 ("IR"), including -
 - (a) a summary of receipts and payments,
 - (b) a statement that he has reconciled his accounts
- (iv) In the case of liquidations where no liquidation or creditors' committee has been appointed, an explanation that it is open to the creditor of a liquidation in the Schedule to apply for an order that the Applicant(s) appointed or remaining Office Holder do provide such information as they may otherwise be required to provide by IR 4 108(3), that is to say an account of the administration or the winding up, including -
 - (a) a summary of receipts and payments,
 - (b) a statement that he has reconciled his accounts
- (v) In the case of members' voluntary liquidation, an explanation that it is open to any member to apply to Court for an order that the replacement or remaining Office Holder do provide such information as they may otherwise be required to provide by IR 4 142(2), that is to say an account of the administration of the estate, including -
 - (a) a summary of receipts and payments,
 - (b) a statement that he has reconciled his accounts
- (vi) In the case of bankruptcies where creditors' committees have been appointed, an explanation that it is open to the committee to require the Applicant(s) appointed or remaining Office Holder to provide such information as they may otherwise be required to provide by IR 6 126(2), that is to say an account of the administration of the estate, including -

- (a) a summary of receipts and payments,
- (b) a statement that he has reconciled his accounts

(vii) In the case of bankruptcies where no creditors' committees have been appointed, an explanation that it is open to any creditors to apply for an order that the Applicant(s) appointed do provide such information as they might otherwise be required by IR 6 126(2), that is to say an account of the administration of the estate including -

- (a) a summary of receipts and payments,
- (b) a statement that he has reconciled his accounts

(viii) Notification that if the Applicant(s) in question have been required to provide the information referred to in paragraphs 8(iii) to (vii) above whether by liquidation or creditors' committee or by Court order on the application of an individual creditor the Applicant(s)' costs of complying with such a request or order shall, unless good reason to the contrary are demonstrated, be paid as costs in the relevant bankruptcy or liquidation estates

(ix) In the case of each bankruptcy and liquidation that the creditors have the right to object and make representations to the Secretary of State in respect of the First Respondent's release within 28 days of the date of the advertisement,

- 9 No further advertisement concerning the removal of the First Respondent and the appointment of the Applicant(s) is required, save for the circulation referred to in paragraph 10 below,
- 10 The Applicant shall when the next report is due to the creditors/members of each company voluntary arrangement, administration, members' voluntary liquidation, creditors' voluntary liquidation, compulsory liquidation, individual voluntary arrangement and bankruptcy appointments and in any event by no later than six months from the date of this order, give notice of the making of this order to such creditors/members, such notice to include the date of the order, the fact of the removal of the First Respondent and the appointment of his replacement(s)
- 11 There be liberty to each creditor/member of each liquidation, company voluntary arrangement, administration, bankruptcy and individual voluntary arrangement to apply to vary or discharge this order within 28 days of the date of the advertisement in the London Gazette referred to in paragraph 8 above
- 12 The First Respondent be released from all liability in respect of his acts and omissions and in

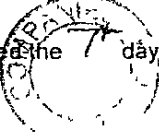
relation to his conduct as Office Holder whilst acting as Administrator in respect of the companies listed in Administration in the attached Schedule, with effect from 31 days after circulation of each report respectively referred to in paragraph 10 above, save in respect of any claim notified by that date to the First Respondent or (where appropriate) his joint Appointee or replacement Office Holder pursuant to the Insolvency Act 1986 and/or pursuant to such other provisions as may apply

13 The First Respondent shall not be at liberty to apply to the Secretary of State for his release from his position as liquidator, whether voluntary or compulsory, or as trustee in bankruptcy until after the expiry of 42 days from the circulation of each report respectively referred to in paragraph 10 above

14 The costs of this Application be apportioned as follows -

- (i) Such remuneration, costs and/or expenses in respect of this Application as are referable to a particular matter in the Schedule shall be fixed and paid in the ordinary way as remuneration, costs and/or expenses in respect of such matters, and
- (ii) Such remuneration, costs and/or expenses in respect of this Application as are not referable to a particular matter shall be divided equally between each of the estates identified in the Schedule and thereafter treated as costs and/or expenses of such estates,

PROVIDED THAT in no case shall the total of such remuneration, costs and expenses (including VAT) payable under (i) and (ii) above exceed 10% of the value of the realised assets in that particular matter
