# **LEGAL STATUS**

The company is limited by guarantee with incorporation on 23 September 2004, and registration as a charity in August 2005. The governing document is the Memorandum and Articles of Association.

# **CHAIRMAN'S REPORT**

I continued in the role of Chairman during this year. There have been no changes of trustees

Maxine Bullen's position as Executive Director came to an end after the contracted period of a year. The trustees are very grateful to Maxine for all she contributed

During 2011, the trustees agreed that the work at The Tree Estate Community Hall had reached the point at which the local community should be more involved in its running and, with the help of Dartford Borough Council, the lease was terminated in 2012. Particular thanks for the operation of the centre during its last year go to Pam Henderson, a resident of the Tree Estate who stepped in to assist in caretaking the centre on an ad hoc basis, and to Kevin Ross for all his help and enthusiasm

Talking Halls project, reported on last year, continued into 2012 and the agreed outcomes were met on time and on budget. A well-attended community event marked the culmination of all the work, together with videos and a printed booklet. The feedback from HLF was that this had been a successful project, and that they would look positively on further applications. An application has been started for a similar project focusing on Gravesend's St George's Church. Our thanks go to Ann Todd and Stephen Brice, the Heritage Interpretation Managers, to Jennie Scott as Programme Development Manager, and to Maxine Bullen. The project was overseen by a group from the local community, ably led by WCW Trustee, John Bennett

Further Race, Faith and Culture events for the voluntary sector have built on a series of events in 2011, led by Maxine Bullen and Jennie Scott

The 'What if...?' Gallery continues to sustain itself, despite the current economic climate, thanks to the efforts of its volunteers led by WCW Trustee Ruth Howard. A special exhibition around the Titanic theme was well attended, and photography workshops in schools also provided material for an excellent exhibition.

Our Bluewater "What is Ok" Project with young people continued to provide a service that was well received by both the management of Bluewater and the young people themselves However, Bluewater felt that this project had reached a natural end and so, sadly, it came to an end in the summer. My thanks to our staff, Jasvinder Bansil and Pawanjit Lotay for all their contributions

Several potential projects are in the development phase, and the mood of the charity is one of optimism. Although we close the year with little by the way of reserves, the organization is determined to build on all that has been accomplished.

# STATEMENT OF TRUSTEES RESPONSIBILITIES
