TRUSTEES' ANNUAL REPORT

FOR THE YEAR ENDED 30 SEPTEMBER 2010

The trustees, who are also Directors for the purposes of the Companies Act, submit their annual report together with the financial statements for the year ended 30 September 2010

LEGAL STATUS

The company is limited by guarantee with incorporation on 23 September 2004, and registration as a charity in August 2005. The governing document is the Memorandum and Articles of Association.

CHAIRMAN'S REPORT

WCW are at present concluding negotiations over the terms of the Memorandum of Understanding with Kent County Council concerning the use of the Old Town Hall in Gravesend, following the successful bid to the Heritage Lottery Fund for the Talking Halls Project, which will run over a period of 15 months, and will involve employing a project Manager to develop a relationship with a group of local volunteers to record the stories of the Old Town Hall. Our thanks to Nadia Ammar, our fundraiser for her work in bringing in this opportunity. Regenerating the Old Town Hall and reconnecting it back to the local people has been our most ambitious project to date and we have spent nearly four years taking us to the stage where we can now operate out of the building

At present there are two smaller projects being run on these premises, one involving young people from the different faith communities and another around teaching adults, with learning difficulties, the art of handbell ringing. This provides us with a gentle lead in to working with people in the Gravesend Community to deliver further projects. At present all of these initiatives have come from Trustees who have generously given of their time and support to make these things happen and we have been greatly helped by two people closely connected with Gravesend. Chris Stone and John Bennett. My thanks to them for their sterling support and advice

We are also very close to an agreement with KCC to match our existing resources with a grant to secure a Director for a period of a year to take the Charity forward in developing additional projects that build on the resources of people of both faith and goodwill from the wider community. I am hopeful that from our work earlier with the faith communities that people will now come forward from these communities to take this work forward.

Should these agreements be concluded and the open evening event to be held on Saturday 30th November be successfully adopted by the various faith communities and interested community partners I shall then step down as Chair and as a Trustee of the Charity I live in Dartford and the Charity has now grown to the point where it now requires a fulltime Director

CHAIRMAN'S REPORT (cont.)

The Charity has reached an interesting stage in its life. The Tree Community in Dartford, where our community development work originally began, are now the recipients of a £1m grant from the big local Lottery Fund, which is to be spent over the next 10 years resourcing the community to develop its capacity to initiate and manage ventures that will bring about wellbeing. This is much welcome news. I know Angie Essex, our Youth worker, on the Tree Estate is rubbing her hands in glee!

There is now the potential as lease owners of the Centre and as the architects of both the Community Forum and the Service Partners Steering Group for the residents and community groups to really flourish and thrive. Our work inspiring collaborative action has truly been lived out here and we should be very pleased with this work and that of regenerating the Old Town Hall in Gravesend.

Regarding our other work we are also well pleased that the What If Arts Gallery is now well established and we are hoping that one of the Volunteers will join the Board of Trustees to oversee its future development

Also our Bluewater "What is Ok" Project with young people continues to provide a service that is well received by both the management of Bluewater and the young people themselves. My thanks to our staff, Megan Swaffer and Jasvinder Bansil for all their contributions over the past year.

We have over the last two years successfully shed other work that is not within our remit and not aligned to our purpose, much of it property maintenance and repairs, which whilst its served us well in the establishment of the Charity distracted us from our vocation to inspire collaborative action that makes Whole Community Works

In all of this I would like to pay tribute to Kevin Ross, who volunteered to join us at a precarious moment in our history and took a risk of faith in leaving behind a secure position to travel into the unknown. Without his perseverance and loyalty we would never have reached this moment. He has been with this organisation in one role or another from the beginning and I know that his future role with the Charity is now at risk. One of the first bits of work my successor will have is to agree what if any of his present responsibilities are retained.

An organisation has a life of its own and it calls people to play a particular role for a particular time. Regarding my own role as founder that too is now over - though I am reluctant to use that phrase "founder" as I just responded to that call from the Founder of us all to respond as best as I knew how. Now it is time for others to respond to new ventures. I wish those who respond every blessing

RESERVES POLICY AND RESULTS
