The company provides nominee services to clients of Kreston Reeves LLP.



Notes to the financial statements For the period ended 31 May 2018

1. General information

The company is a private company limited by share capital incorporated in England & Wales. The address of the registered office and principal place of business is 9 Donnington Park, 85 Birdham Road, Chichester, West Sussex, PO20 7AJ.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

2.2 Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value.

3. Related party transactions

Spofforths LLP is the sole shareholder of the company. During the year Donnington Corporate Services Limited provided fiduciary services on behalf of clients of Spofforths LLP and its successor business Kreston Reeves LLP. All remuneration has been accounted for in the accounts of Kreston Reeves LLP.

4. Controlling party

The immediate parent undertaking is Spofforths LLP, whose members are Kreston Reeves LLP and RCPP Spofforth. The company is controlled by the designated members of Kreston Reeves LLP. Copies of the group financial statements may be obtained from the registered office.
