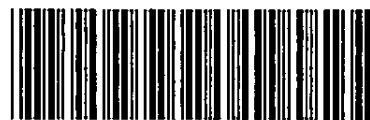

2. The Debt which is secured on the Property and other assets




