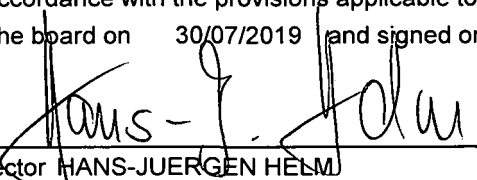

1. ACCOUNTING POLICIES

1.1. Basis of preparation of financial statements

1.2. Cash flow
