UPON the Application for a block transfer order dated 25 November 2020

AND UPON READING the evidence filed

IT IS ORDERED THAT:

- Each of the High Court cases listed in the Schedules (attached to this Order) (the Block Transfer Cases) be transferred to the High Court of Justice, Chancery Division, Business and Property Courts in Leeds for the purpose only of making this Order.
- 2. Immediately upon this Order taking effect, the Block Transfer Cases be transferred back to their original location of High Court.

- 4. Lindsey Jane Cooper, Christopher Ratten and Keith Jeffery Algie (the Replacement Officeholders) be appointed as replacement officeholders in respect of each of the Block Transfer Cases as listed in the Schedules (attached to this Order) from the date of this Order pursuant to Rule 12.37(3) of the Rules without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the Block Transfer Cases (ii) apply to the Secretary of State for release or discharge pursuant to the Insolvency Act 1986 or (iii) file a receipts and payments account.
- 5.
