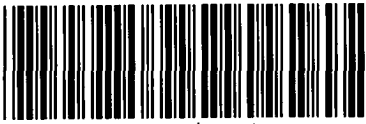

1. ACCOUNTING POLICIES

1.1. Basis of preparation of financial statements

The full financial statements, from which these [] accounts have been extracted, have been prepared under the historical cost convention and in accordance with the German tax law.

1.2. Cash flow
