1. STATUTORY INFORMATION

2. ACCOUNTING POLICIES

Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Going Concern

The Directors are required to consider the appropriateness of the going concern basis for the company. The directors have considered the resources available to the Company, the plans for the future and are confident that the company can continue as a going concern. As a result the company continues to adopt the going concern basis in preparing its financial statements.

Significant judgements and estimates

Turnover

Turnover is measured at the fair value of the consideration received or receivable, excluding discounts, rebates, value added tax and other sales taxes.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Computer equipment - 25% on cost

Pension costs and other post-retirement benefits

The company operates a defined contribution pension scheme. Contributions payable to the company's pension scheme are charged to profit or loss in the period to which they relate.

Grants receivable

Grants are accounted for in the period to which they relate. The amount of any grant received which relates to future periods is shown as a creditor in the accounts.

Donations received

Donations are recognised on a receivable basis where there is certainty of receipt and the amount can be reliably measured.
