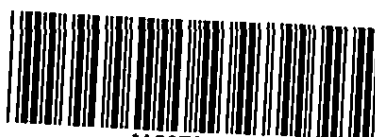

ORDER

UPON the Application of the Applicant for a Block Transfer Order of the appointments held by the Respondent dated 27 December 2012

AND UPON reading the papers on the Court file

IT IS ORDERED that:

1. The cases listed in Schedules attached hereto, in so far as they are currently proceedings in a County Court, High Court or in another District Registry, be transferred to the Birmingham District Registry for the purpose of making the orders listed below
2. In relation to all the Creditors' Voluntary Liquidation proceedings set out in Schedule A and C hereto, Michaela Heeley be removed from office as Liquidator of the Companies in Liquidation and Costas Morfakis be appointed Liquidator of the same in her place with effect from the date of this Order,

- 3 In relation to all the Creditors' Voluntary Liquidation proceedings set out in Schedule B hereto, Michaela Heeley be removed from office as Liquidator of the Companies in Liquidation with effect from the date of this Order,
- 4 In relation to the Administrations identified in Schedule D hereto, Michaela Heeley be removed from office as joint Administrator of the Companies in Administration and Costas Morfakis be appointed as joint Administrator of the same in her place with effect from the date of this Order,
- 5 Michaela Heeley shall be at liberty to apply to the Secretary of State for her release in respect of the insolvency appointments listed in the Schedules after the expiry of 28 days from the date when the relevant notice referred to in paragraph 6 below has been given, save in respect of any claim notified by that date;
- 6 Costas Morfakis shall give notice of this Order to all creditors of the estates listed in the Schedules within 28 days of the date of this Order, either by letter or by means of an advertisement in the London Gazette
- 7 All creditors of the estates listed in the Schedules attached hereto do have permission to apply to the Court, on notice to Costas Morfakis, within 28 days of the abovementioned Notice for the purpose of applying to vary or discharge this Order in so far as it affects the estate or estates of which they are a creditor,
8. Michaela Heeley be discharged from liability as administrator in respect of the companies identified in Schedule D hereto with effect from 28 days after the date of the above mentioned (paragraph 6) advertisement in the London Gazette;
- 9 The time for service of the Application Notice upon Michaela Heeley be abridged,
- 10 Costas Morfakis will attend to all and any necessary reports to creditors (subsequent to the date of this order) required under the Insolvency Rules 1986 the costs of which will be charged as a cost or expense of the estates listed in the Schedules attached hereto (each estate to bear an equal share, but with no estate having to bear an amount exceeding 10% of available funds in that estate);
11. Costas Morfakis' costs of this Application be charged as a cost or expense of the estates listed in the Schedules attached hereto (each estate to bear an equal share, but with no estate having to bear an amount exceeding 10% of available funds in that estate);
- 12 Michaela Heeley's costs in the agreed sum of £3,000.00 (plus VAT) will be paid by Costas Morfakis personally within 14 days of this order;
- 13 Permission to apply, and
- 14 This Order has been made by the Court under CPR 23.9 as the Court has disposed of this Application without a hearing and without service of the same on the Respondent and the parties therefore have the right to make an application to set aside or vary this Order under CPR 23.10.
