OBJECTS

The Objects of the Company are

To relieve the needs of asylum seekers and refugees by the provision of information, advice and support

To preserve and protect the physical and mental health of asylum seekers and their dependants and those granted refugee status and their dependants

To advance the education of the public in general about the issues relating to refugees and those seeking asylum

To provide facilities for recreation or other leisure time occupation with the object of improving the conditions of life of those persons who have need of such facilities

To promote human rights (as set out in the Universal Declaration of Human Rights and subsequent United Nations conventions and declarations) by all or any of the following means -

- · relieving need among the victims of human rights abuse
- · conducting research into human rights issues
- educating the public about human rights
- raising awareness of human rights issues
- promoting public support for human rights
- promoting respect for human rights among individuals and corporations

REVIEW OF DEVELOPMENTS, ACTIVITIES, ACHIEVEMENTS AND FUTURE DEVELOPMENT

The past year has been busy and successful Bristol Refugee Rights has consolidated work started in 2006 on both practical and campaigning work in support of people who seek sanctuary in the UK. We have many people and groups to thank for contributing to our success.

In August 2007 we officially changed the name of the project from 'Holding Refugees and Human Rights in Mind' to the more succinct 'Bristol Refugee Rights' and this is the name by which the project is now widely known

Last summer saw the start of the Human Rights arm of Bristol Refugee Rights in accordance with the stated aims and objectives of the project. A group of trustees and volunteers are developing ideas around public education and campaigns on human rights issues for asylum seekers and refugees. This invaluable work dovetails with support for individuals at the weekly drop in centre.

THE WELCOME CENTRE

Finding a home

In August 2007 St Nicholas of Tolentino Church began an extensive building programme, we kept our office there but moved the drop in to its present home close by in the Congregational Chapel Hall Rev David Thomas gave us a warm welcome and put at our disposal the large hall and a number of smaller rooms.

Numbers grew rapidly and we are grateful for the space the Chapel offers and the friendly welcome from the Minister and staff. In April, alongside the congregation, we were shocked and saddened by the death of the Rev Thomas A delegation from Bristol Refugee Rights attended his funeral.

Service users

We now see an average of 40 service users on Wednesdays and 80 to 100 on Thursdays. We have over 500 registered service users from 34 different countries. About two thirds of these are men, and one third women A large majority are under 30. 50 are children

Staffing

The Centre Coordinator, Caroline Beatty, continues to coordinate the Welcome Centre and its success owes a lot to her hard work and dedication. In October 07, we appointed Sue Scott to coordinate the ESOL classes, which remain highly popular and well attended. We would like to thank both staff members for their hard work and energy.

We have a group of 50 regular volunteers who bring many skills and without whom the centre could not function. About a quarter of these first came to the centre as service users themselves. Volunteers' generosity, good humour and commitment make the centre a real place of welcome.

We have provided placements for 5 students, from Bristol University and UWE social work courses, and City of Bristol Community Volunteering course.

Classes and activities

- ESOL Classes run at five levels and each class now has its own room. Attendance is high with an average of over 30 learners per session.
- Excursions have been made using Bristol Community Transport to @Bristol, Blaise, the Zoo, The Cube Cinema, an evening at the Colston Hall, and summer trips are planned to Weston, the Harbour, and St Fagan's
- The volunteer led advice service is much in demand and urgently in need of further resources. We are grateful to Victoria Long and Beth Cooper, both from the Law Centre, for their professional input.
- Service users produce powerful work in weekly art sessions. Two displays were contributed during Refugee Week to the Pierian Centre and to the Easton Arts Trail.
- A Maths class, introduced at the request of service users is led by a qualified teacher, who is herself seeking asylum
- The creche is staffed by 3 qualified workers. It is well used and supports parents to join in centre activities

Involvement in the Community

- Supported by volunteers, service users work regularly in the Trinity Centre community garden, and are now also using the computers in the Trinity Centre
- Service users contributed to the King Costa show in Colston Hall, and to the Queen Square day in Refugee Week
- 10 service users and volunteers took part in a three hour radio workshop at BBC studios, designed to support people to tell their stories.

Networks and links

As essential part of BRR's work is in making links with other groups, to extend our support out into the community and help to create a robust and flexible service

- The drop in provides a contact point for organizations that work with new arrivals and new refugees, including Red Cross, NHS services, Single Parent Action Network, the Refugee Support Project, Refugee Women of Bristol, Bristol Defend Asylum Seekers Campaign, Womankind.
- We have regular contact and support from the Law Centre, Refugee Action, Bishopston Bread Store, the Bike Guru, Sustainable Frome and Time Together.

We would particularly like to thank our partner organization St. Nicholas of Tolentino, Father Richard McKay and Sister Liz Ferrie for their continued support.

Political engagement and wider membership

Kerry McCarthy, MP for Bristol East, visited in April and, spoke with 3 destitute Somali women whose claims were refused 5 or more years ago, but who have not been returned. She expressed concern about their plight. She has taken up cases of individual service users living in her constituency. Roger Berry, MP for the Kingswood area, is regularly approached by service users living in South Gloucestershire, and visited the centre in July.

Cllr Havvock and Cllr Malik visited the centre to discuss the work we are doing. We are grateful for their continued support

Membership of Bristol Refugee Rights continues to grow and we plan to develop regular communication to keep members, friends and other interested parties abreast of developments.

Challenges for the future

The need for the drop in centre is well demonstrated by its growing usage over the past 2 years.

- The centre now opens for 2 days there is a strong call to open more days.
- The advice service urgently needs resourcing
- Our volunteers ment more support in the form of a volunteer coordinator

Human Rights Campaigning

Through daily contact with people in the drop in we have come to understand directly and in a very personal way the asylum process and its effect on people's lives. Our experience accords with many of the findings of the 4 excellent reports of the Independent Asylum Commission, published in summer 2008.

Matters of particular concern to us

- 1. 75% of asylum claimants are refused asylum here they all face destitution. As we get to know people we understand how the asylum system lets down those who desperately need it.
- The final tier of support Section 4 available under certain conditions to those who would otherwise be destitute. This requires people to live on the shockingly low weekly sum of £35 issued not in cash but in the form of supermarket gift cards.
- Detention of children Two young children in our 'family' at the Welcome centre were detained for 9 weeks between them over the past few months This has given us some shocking first hand information on the treatment of families in Yarl's Wood removal centre
- We firmly support the IAC recommendation that anyone whose case has taken more than 6 months to determine, should have the right to work to maintain themselves. This should also apply to those who have been refused but not removed

These concerns will form the basis of our campaigning work over the coming year.

CONCLUSION

It has been a busy and exciting year which has seen rapid development as well as consolidation of earlier initiatives. With so much help and support from such a wide range of people and organizations it has not been possible to mention everyone. A list of our funders is provided below. Without this help Bristol Refugee Rights would not have flourished to the extent that it undoubtedly has, and shows that the project is much needed
