#### INTRODUCTION

Newman Employment Services Limited (Entity) entered members' voluntary liquidation on 23 October 2019. Steven Sherry and Emma Cray were appointed joint liquidators of the Entity (Liquidators).

This report covers the conduct and progress of the liquidation in the period from 23 October 2019 to 22 October 2020 (Period).

A summary of receipts and payments for this Period is at Appendix A.

The statutory information relating to the Entity and the Liquidators is at Appendix B.

#### REPORT ON THE LIQUIDATION

#### Realisation of assets:

Following their appointment, the Liquidators took control of the assets listed in the directors' Declaration of Solvency, which showed the Company's assets consisted of a VAT refund of £438 only.

During the Period, a VAT reclaim was submitted to HM Revenue & Customs for a total of £437.96. As the Entity does not operate a bank account, the Liquidators instructed HMRC to pay the reclaimed amount directly to the Entity's Member, Third Energy Holdings Limited, to hold on trust on behalf of the Entity pending formal distribution.

The Liquidators have not identified any additional assets of the Entity in the Period and are not aware of any other assets that remain to be realised.

#### Settlement of liabilities:

The directors' Declaration of Solvency showed that the Entity had no liabilities.

In the Period, the Liquidators published a notice in the London Gazette inviting creditors to submit details of claims they may have against the Entity.

The Liquidators have not received any claims in the Period.

#### HM Revenue & Customs ("HMRC"):

In the Period, the Liquidators wrote to HMRC to inform them of the liquidation and to request details of any outstanding liabilities.

The Liquidators received a claim from HMRC for £500, relating to the late filing penalty of the Corporation Tax return for the period ended 31 December 2018. Third Energy Holdings Limited, the Entity's member, has settled the outstanding tax liability, together with accrued interest.

As there were no funds in the estate, the Entity's Member, Third Energy Holdings Limited, agreed to settle all costs associated with the liquidation of the Entity and two other connected entities.
