

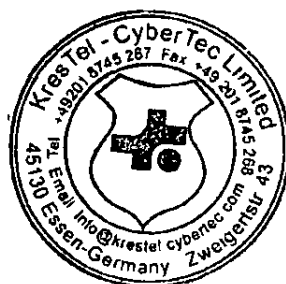

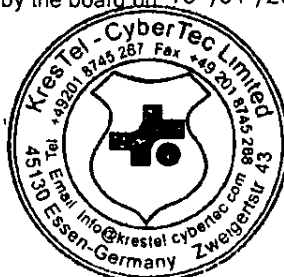

1 ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The full financial statements, from which these abbreviated accounts have been extracted, have been prepared under the historical cost convention and in accordance with the German tax law

1.2 Cash flow

Turnover comprises the invoiced value of goods and services supplied by the company, exclusive of Value Added Tax

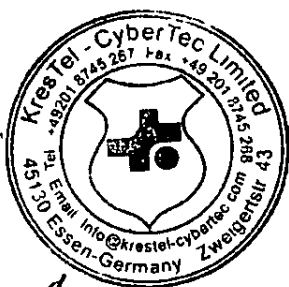
1.4 Foreign Currencies
