**DISAPPLICATION OF PRE-EMPTION RIGHTS**


1. THAT, the Directors be authorised to allot "New Securities" (as defined in the Company's articles of association) pursuant to the authority conferred by Article 36.2 of the Company's articles of association, as if the term "New Securities" did not apply to such allotment (and therefore that the pre-emption procedure set out in Article 36.3 did not apply), provided that this power shall:
  - 1.1. be limited to the allotment of equity securities up to a total aggregate value of 800,000 GBP at a price of 0.20 GBP per share; and
  - 1.2. expire on [30 April 2019] (unless renewed, varied or revoked by the Company prior to or on that date).
