### **PRINCIPAL ACTIVITIES**

The principal activity of the organisation is to help Ghanaian women in the Community.

The company was dormant during the financial year ended 31 August 2014 no transactions had taken place.

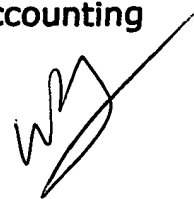
