IT IS ORDERED that -

- 1 In respect of those Administrations, Creditors' Voluntary Liquidations, Members Voluntary Liquidations, Company Voluntary Arrangements, Partnership Voluntary Arrangements, Individual Voluntary Arrangements and Bankruptcies listed in the Schedules to this Application which are the subject of proceedings in the County Court, those proceedings be transferred to the High Court solely for the purpose of this Application and thereafter transferred back to the County Court
- 2 Richard Albert Brock Saville be removed from his office as Liquidator and Supervisor (as the case may be) of the Estates listed against his name in the Schedules at pages 14 to 21 inclusive with immediate effect save that he remains in office as joint liquidator to The Phoenix Partners Limited (page 16) and remains in office for those appointments at pages 22,24 and 25 and, in the case of IT4B Limited on page 23 where he is appointed as replacement
- 3 Robert Michael Young be removed from his office as Administrator, Liquidator, Supervisor and Trustee in Bankruptcy (as the case may be) of the Estates listed against his name in the Schedules with immediate effect
- 4 Peter Andrew Blair be removed from his office as Administrator, Liquidator, Supervisor and Trustee in Bankruptcy (as the case may be) of the Estates listed against his name in the Schedules with immediate effect.



- 5 Steven John Currie be removed from his office as Administrator, Liquidator, Supervisor and Trustee in Bankruptcy (as the case may be) of the Estates listed against his name in the Schedules at pages 1 to 12 inclusive as applicable with immediate effect and is appointed joint liquidator of The Phoenix Partners Limited (page 16) and replaces Peter Andrew Blair as appropriate to those appointments on pages 22 to 25 inclusive.
- 6 Richard Albert Brock Saville, Robert Michael Young, Peter Andrew Blair and Steven John Currie be replaced with such office holder or jointly by such office holder in the case of each such estate by such of the Applicants as the case may be named in the Schedules as the proposed replacement with immediate effect
- 7 In the cases where the said Richard Albert Brock Saville, Robert Michael Young, Peter Andrew Blair and Steven John Currie are replaced as Administrators the office holders replacing them in each case shall additionally replace them as the nominated joint Liquidator under the terms of the Administrators proposals for the purposes of placing the Company into creditors' voluntary liquidation.
- 8 The removal and appointments granted by this Order shall not disturb the existing reporting cycle for each of the respective insolvency appointments listed in the Schedules and the current time limit for reporting to creditors on each of the insolvency appointments shall continue irrespective of the removal and appointments made by this Order
- 9 The provisions contained in Insolvency Rules 2 47(3)(A), 4 49B(5), 4 49C(3) and 6 78A(4) of the Insolvency Rules 1986 or any other such reporting requirements shall not apply and Richard Albert Brock Saville, Robert Michael Young, Peter Andrew Blair and Steven John Currie are not required to produce any progress reports on ceasing to act as officeholder of the insolvency appointments listed in the Schedules



- 10 Richard Andrew Brock Saville, Robert Michael Young, Peter Andrew Blair and Steven John Currie shall be granted their release as appropriate 28 days after the publication in the London Gazette referred to below
11. The Applicants be entitled to publish in the London Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette within 14 days of receipt of the sealed Order and shall file any appropriate notices in respect of the removal of Richard Andrew Brock Saville, Robert Michael Young, Peter Andrew Blair and Steven John Currie and the appointment of replacement office holders and those appointments with the Registrar of Companies and the Secretary of State for Business Innovation and Skills (Insolvency Services) as appropriate
- 12 Notice of this Order shall also be given to the creditors in each case in the next statutory report for each insolvency administration listed in the schedules
- 13 Liberty to each creditor of each estate to apply to vary or discharge this Order within 28 days of the date of publication of the Gazette notice directed to be sent under paragraph 11 above
- 14 Service of the Notice of the Application be dispensed with
