

LIQUIDATOR'S ACTIONS SINCE LAST REPORT

Since my last report my investigations into the affairs of the company, and the directors conduct remain ongoing in respect of this company and other connected companies and associates. I have continued to instruct Brachers LLP Solicitors to provide advice, however at this stage I cannot divulge full details of my investigations.

There is certain work that I am required by the insolvency legislation to undertake in connection with the liquidation that provides no financial benefit for the creditors. A description of the routine work undertaken since my last progress report is contained in Appendix 1.

RECEIPTS AND PAYMENTS

My Receipts & Payments Account for the period from 19 October 2019 to 18 October 2020 is attached at Appendix 2.

There have no receipts during this period

Payments

Bank Charges

The sum of £88.00 has been paid with respect to ISA quarterly fees charged at £22 per quarter.

The balance of funds is held in a non-interest bearing account at the Insolvency Services Account.

LIABILITIES

Secured Creditors

An examination of the Company's mortgage register held by the Registrar of Companies, showed that the Company has no current charges over its assets.

The legislation requires that if the Company has created a floating charge after 15 September 2003, a prescribed part of the Company's net property (i.e. the money that would otherwise be available to the charge holder) should be ring-fenced for distribution to unsecured creditors. In this case there were no creditors secured by a floating charge such that the prescribed part provisions do not apply.

Preferential Creditors

The statement of affairs did not anticipated any preferential creditors. No claims have been received.

Crown Creditors

The statement of affairs included £353,039.70 owed to HMRC. HMRC's claim of £763,205.11 has been received.

Non-preferential unsecured Creditors

The statement of affairs included no non-preferential unsecured creditors. I have not received any claims.

DIVIDEND PROSPECTS

Any dividend is dependent upon the outcome of my investigations.

INVESTIGATION INTO THE AFFAIRS OF THE COMPANY

As stated previously, my investigations into the affairs of the company remain ongoing.

LIQUIDATOR'S REMUNERATION

My remuneration has not yet been authorised by creditors. My total time costs to 18 October 2020 amount to £43,150.50, representing 152.75 of hours work at a blended charge out rate of £282.49 per hour, of which

£2,553.50, representing 12.4 of hours work, was charged in the period since 19 October 2019, at a blended charge out rate of £205.93 per hour

I have not been able to draw any remuneration in this matter.

LIQUIDATOR'S EXPENSES

The choice of professionals was based on my perception of their experience and ability to perform this type of work and the complexity and nature of the assignment. I also considered that the basis on which they will charge their fees represented value for money. I have reviewed the charges they have made and am satisfied that they are reasonable in the circumstances of this case.

FURTHER INFORMATION

An unsecured creditor may, with the permission of the Court, or with the concurrence of 5% in value of the unsecured creditors (including the creditor in question), request further details of the Liquidator's remuneration and expenses within 21 days of their receipt of this report. Any secured creditor may request the same details in the same time limit.

An unsecured creditor may, with the permission of the Court, or with the concurrence of 10% in value of the unsecured creditors (including the creditor in question), apply to Court to challenge the amount of remuneration charged by the Liquidator as being excessive, and/or the basis of the Liquidator's remuneration, and/or the amount of the expenses incurred as being excessive, within 8 weeks of their receipt of this report. Any secured creditor may make a similar application to court within the same time limit.
