### **1. Accounting policies**

These financial statements have been prepared in accordance with the provisions of Section 1A (Small Entities) of Financial Reporting Standard 102

#### **Turnover policy**

Turnover is measured at fair value of the consideration received or receivable. Turnover is reduced for customer returns, rebates and similar allowances, and is stated net of value added tax. Specifically, revenue from the sale of goods is recognised when the goods are delivered and legal title passed.

#### **Tangible fixed assets and depreciation policy**

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their fair estimated residual value, over their expected useful lives on the following basis: Leasehold Improvements 10% Straight Line Plant & Office Equipment 25% Reducing Balance Motor Vehicles 25% Reducing Balance

#### **Valuation and information policy**

Stocks and work in progress are valued at the lower of cost or net realisable value after making due allowance for impairments, obsolete and slow moving stocks. Costs include all direct costs and an appropriate proportion of fixed and variable overheads.

#### **Other accounting policies**

Deferred Taxation- The charge for taxation takes into account taxation deferred as a result of timing differences between the treatment of certain items for taxation and accounting purposes. Foreign Currencies- Monetary assets and liabilities in foreign currencies are translated to sterling at the rates of exchange ruling at the balance sheet date. Transactions in foreign currencies are translated into sterling at the rate ruling on the date of the transaction. Exchange rate differences are taken into account in arriving at the operating profit.
