1. Principal Accounting Policies

Basis Of Preparation

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Going Concern

The company made a loss of £733,523 for the year ended 31 March 2015 and at that date, had net liabilities of £2,566,233.
