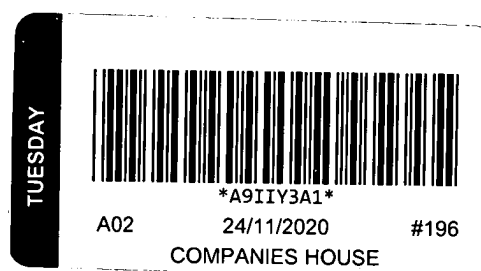


**2 Accounting policies****Basis of accounting**
