ORDER

UPON the Applicants' Application dated 6 June 2022 ("the Application")

AND UPON reading the Witness Statement of the First Applicant in support of the Application dated 1 June 2022

AND UPON the Court being satisfied that the Respondents to the Application have all been served and all consent to the Application

AND UPON the Court being satisfied that the Secretary of State for Business, Energy and Industrial Strategy has been served

IT IS ORDERED THAT:-

1. Stephen Anthony John Ramsbottom be removed from office as Liquidator in respect of the companies in Creditors' Voluntary Liquidation set out in schedule A hereto from the date of this order.
2. Stephen Anthony John Ramsbottom be removed from office as Liquidator in respect of the companies in Members' Voluntary Liquidation set out in schedule B hereto from the date of this order.
3. Stephen Anthony John Ramsbottom be removed from office as Administrator in respect of the companies in administration set out in schedule C hereto from the date of this order.
4. Colin Wilson be appointed as joint replacement office holder in respect of each of the cases listed in schedules A, B and C from the date of this Order.
5. The creditors in each of the cases listed in schedules A, B and C be notified of this order by advertisement in the London Gazette within 21 days of the date of this order.
6. Any creditor in respect of any of the companies listed in schedules A, B and C who has an objection to this order shall have 14 days from the date of advertisement in the London Gazette, in accordance with the preceding paragraph, to apply to Court to set aside or vary the terms of the order. Such Application shall not affect the transfer of the cases listed in schedules A, B and C until further order or other order by the Court.
7. The Applicants shall give notice to the Secretary of State for Business, Energy and Industrial Strategy in respect of the liquidations listed in schedules A and B and of the administrations listed in schedule C and of the terms of this order as soon as reasonably practicable.

8. Stephen Anthony John Ramsbottom shall receive his release as Liquidator and administrator respectively 28 days after the giving of notice to creditors in accordance with paragraph 5 of this order, save that such release may be subject to further order in the event of an application by any creditor under paragraph 6 of this order for the specific case subject to that application.
9. The costs of and occasioned by this application related to the administrations as set out in Schedule C shall be paid as an expense of the respective administration.
10. The costs of and occasioned by this application insofar as they relate to the Creditors' Voluntary Liquidations as set out in Schedule A and the Member Voluntary Liquidations as set out in Schedule B shall be paid by Opus Restructuring LLP.
