#### Year ended 31 March 2018

#### Objectives and activities

#### Foreword

The organisation has continued to concentrate on its domestic abuse project and as detailed in the attached report has developed a number of programmes. In particular for women these are the Recovery Toolkit and You & Me, Mum. For children there is the Healing Together programme and a Children's Recovery Toolkit.

At all times in planning our activities the charity has referred to the guidance contained in the Charity Commission's general guidance on public benefit and how the activities will contribute to the overall aims and objectives we have set.

#### Safeguarding

Safeguarding means protecting individuals from the risk of abuse or neglect. The Safeguarding policies for children's and adults have now been amalgamated and updated. Our Designated Trustee for Safeguarding is in place. We work very closely with the safeguarding team at Birmingham South Central Clinical Commissioning Group and maintain all safeguarding principles. We also work very closely with the Birmingham Safeguarding Adults Board (BSAB), which has responsibilities for seeking assurance regarding domestic abuse under the Care Act 2014. We have signed the Memorandum of Understanding and are a member of the BSAB Partnership Board.

#### Financial review

#### General

The total income for the charity, grants and donations, during the year was £124,342 (2017. £105,298). Although specific grants are received they are all directed towards the core work of the charity and are therefore considered unrestricted in their use.

Total expenditure was £98,261 (2017: £78,710). The net result was a surplus for the year of £26,081 (2017: £27,188). This amount has been added to reserves leaving a balance carried forward for future use of £52,676.

#### **Acknowledgements**

We are ever grateful for Big Lottery Reaching Communities Grant for funding during the last three years. We have witnessed so many life changing moments for women and children in that time which would not have been possible without this grant. We are also grateful to the Grimmitt Trust, Birmingham City Council, Heart of England NHS Foundation Trust and West Midlands Police Commissioner who provided funding for for programmes and creative activities.

#### **Reserves Policy**

The charity's current policy is to maintain sufficient reserves to enable it to pay salaries and other operating costs for a period of three months. At present levels of costs this is estimated to be £20,000. Excess monies will be used to develop and expand programmes and projects and, hopefully increase staffing levels.

#### Plans for future periods

Our plans for the future are to develop on our success during the past year and to grow the projects and the programmes that we are able to offer. More information on this is incorporated in the attached detailed report.

#### Structure, governance and management

Allens Croft Project is a company limited by guarantee governed by its Memorandum and Articles of Association dated 11 February 2008 and is registered as a charity with the Charities Commission.

#### Organisation

The Board of Trustees meets bi-monthly. (The Project Manager has delegated authority for day to day operational and business matters). Significant decisions are dealt with by the Board.

#### **Related Parties**

In previous years Allens Croft Project maintained a close relationship with The Hub, Hazelwell, sharing common trustees, and carried out work on behalf of The Hub. The Hub made financial contributions to the charity to assist with salary payments.

The current board of trustees are all professionals who are either currently involved with or who have recently retired from the NHS. It is possible that at some times there will be work carried out for organisations in which the directors have significant influence and as such will need to be reported.

#### **Funding**

The Company receives grants from various grant making bodies in order to assist with salaries and pay for various activities. It also receives donations. It does not actively seek money from the general public but does not reject any donations that may be offered.

#### Risk Management

The Trustees have a Risk Management strategy which involves

- · Governance a review of how the risk affects our aims.
- Operational Service quality, safeguarding, child protection and health and safety.
- Financial reviewing adequacy of reserves and cash flow.

#### Safeguarding

Safeguarding means protecting individuals, children & adults from the risk of abuse or neglect. The trustees & employees have a clear commitment to safeguarding, ensuring it is everyone's business. The Safeguarding policies for children and adults have now been reviewed to reflect the most up to date legislation and practice and our Designated Trustee for Safeguarding is in place. We work very closely with the safeguarding team at Birmingham South Central Clinical Commissioning Group and have a clear understanding of the effects of domestic violence and abuse on a child's development and well-being. This is why we are committed to a service which empowers women and reinforces their abilities to parent and protect their children. We also work very closely with the Birmingham Safeguarding Adults Board (BSAB), which has responsibilities for seeking assurance regarding domestic abuse under the Care Act 2014. We have signed the Memorandum of Understanding and are a member of the BSAB Partnership Board.

#### 1. General information

The charity is a private company limited by guarantee, registered in England and Wales and a registered charity in England and Wales. The address of the registered office is St Bede's Church, Bryndale Avenue, Birmingham, B14 6NG.

#### 2. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Charities Act 2011.

#### 3. Accounting policies

#### Basis of preparation

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

#### Going concern

There are no material uncertainties about the charity's ability to continue.

#### **Disclosure exemptions**

The charity meets the definition of a public benefit entity.

It satisfies the criteria of being a qualifying entity as defined in FRS 102 and as such the trustees have taken advantage of the exemption and have not prepared a cash flow statement for the company.

#### Judgements and key sources of estimation uncertainty

Significant judgements

There are no judgements (apart from those involving estimations) that management has made in the process of applying the entity's accounting policies that have any significant effect on the amounts recognised in the financial statements.

Key sources of estimation uncertainty

Accounting estimates and assumptions are made concerning the future and, by their nature, will rarely equal the related actual outcome. The trustees do not consider however that there are any key assumptions or other sources of estimation uncertainty that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

#### Accounting policies (continued)

#### Fund accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for particular future project or commitment.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

#### Incoming resources

All income is included in the statement of financial activities when entitlement has passed to the charity, it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the
  contracted service. This is classified as unrestricted funds unless there is a contractual
  requirement for it to be spent on a particular purpose and returned if unspent, in which case it
  may be regarded as restricted.

#### Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, noncharitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking
  activities that further its charitable aims for the benefit of its beneficiaries, including those
  support costs and costs relating to the governance of the charity apportioned to charitable
  activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

#### Tangible assets

All fixed assets are initially recorded at cost.

#### Depreciation

Depreciation is calculated so as to write off the cost or valuation of an asset, less its residual value, over the useful economic life of that asset as follows:

Computers - 33% straight line

#### **Defined contribution plans**

Contributions to defined contribution plans are recognised as an expense in the period in which the related service is provided. Prepaid contributions are recognised as an asset to the extent that the prepayment will lead to a reduction in future payments or a cash refund.

When contributions are not expected to be settled wholly within 12 months of the end of the reporting date in which the employees render the related service, the liability is measured on a discounted present value basis. The unwinding of the discount is recognised as an expense in the period in which it arises.

#### 4. Limited by guarantee

The company is limited by guarantee and consequently has no share capital.

# INTRODUCTION FROM CHAIR

This has been a very significant year for the Birmingham Freedom Project for a host of reasons - in some ways it is a year that might well come to define us and our City. The highlights of the year are twofold - firstly, setting up a fourth programme written by Sue Penna and Rockpool - "ACE Recovery Toolkit". We already have a large group of women on the first programme building resilience and developing strategies to reduce the impact on themselves and their children. Secondly, the Project purchased the license for the film "Resilience", and we have had numerous screenings across Birmingham - the challenge we give is to inspire Birmingham and the wider West Midlands to become truly "trauma informed". Nonetheless, the day to day work of the Project continues and we see women recovering from trauma and abuse through the Freedom Programme, Recovery Toolkit and You and Me Mum.

We've had some comings and goings which are very significant. Tom Odey served the project magnificently as financial lead and trustee for almost 3 years. The work he did was above and beyond and we are very grateful for his services. Similarly, Jane Huffer stepped in as secretary to the trustees and performed a great job but has sadly resigned too. The Project is very grateful for all the good they both did. We are joined by John Guggenheim as our new financial lead and trustee with a wonderful pedigree of public service and financial expertise in the NHS over many decades, and Jo Willis as our employed administrator. We are grateful too for the development work and clinical support Cherry has performed as a consultant to the Project.

For the first time in its history we have introduced performance related pay which has helped us to extend the work of the project into new and challenging areas.

Everything spins round Jacky and Donna who tirelessly support the women in the project with endless energy, wisdom, laughter and grace. I cannot sing their praises high enough, and, as ever, it is a joy for me to help lead the Project and help support them as they support me.

My final thought is with the words of Dr. Bruce Perry -

"Wind can caress or cut, water can quench or drown, and fire can warm or consume. And so it is with human relationships- we can create or destroy, nurture or terrorise, traumatise or heal each other"

The project creates, nurtures and heals. We are ambitious to carry this forward into the heart of our City and Region."

Last year's annual report ended awaiting news of our application for continuation of our Reaching Communities Lottery grant. A grant from Birmingham Community Safety Partnership enabled us to continue delivering services whilst the application process took place. We are delighted to announce that our bid was successful and we have been granted a further three years funding.


The funding also enabled us to appoint a much-needed Administrator to support our work. After working as a team of two for so many years, Jo Willis was appointed to the new role and has fitted into our small team perfectly. To settle Jo in to her role and to welcome her into the fold we organised a team building day. We had lunch followed by a visit to the Royal Shakespeare Theatre to see a play written by the female playwright Mary Pix who at the time would have faced criticism and hostility from breaking away from the stereotype that a woman's place was in the home. We thought this was fitting with our work in empowering and celebrating women. It is so important for organisations to support staff to take time out to reflect, relate and refresh. It was a wonderful day celebrating the hard work and dedication of our team and planning ahead for the next three years and beyond.

With the support of the Building Capabilities funding built into the bid, this year also saw the revamp of policies and procedures and the production of a new staff handbook. Further work will take place over the coming months concentrating on staff and trustee development, data collection and social impact development to provide detailed outcome evidence.

#### **RESILIENCE FILM**

In April 2017 we attended the International Congress in London to hear from some of the world's leading trauma experts including Bessel van der Kolk, Dan Siegel and Louis Cozolino whose works we have built into the programmes we deliver. Whilst there we attended the UK launch of the documentary - RESILIENCE: THE BIOLOGY OF STRESS AND THE SCIENCE OF HOPE. We were adamant that it needed to be seen by as many people as possible and with a donation we received from a supporter we purchased the license and were the first organisation to bring the film to Birmingham. 'The one-hour documentary delves into the science of Adverse Childhood Experiences (ACEs) and the birth of a new movement to treat and prevent Toxic Stress. Now understood to be one of the leading causes of everything from heart disease and cancer to substance abuse and depression, extremely stressful experiences in childhood can alter brain development and have lifelong effects on health and

behaviour'. We have held 15 screenings so far with a diverse range of organisations in attendance including; police, social workers, teachers, family support workers, students, fire fighters, health visitors, midwives, probation officers, domestic abuse workers and mental health workers. Such is the interest that we have started to hold bi-monthly screenings at our base for interested individuals or teams.



Two stand out quotes from the film are from Dr. Jack Shonkoff, Paediatrician and Director at the Center on the Developing Child at Harvard University "If we want to produce dramatic impacts on the outcomes for kids experiencing toxic stress, we have to change the life of the adults who are taking care of them" and "If I had to boil it down for one thing for people to learn from this science, it's to totally put to bed forever this sense that children who are born under disadvantaged circumstances are doomed to poor life outcomes. The science is saying that's just not true."

With that in mind we are in a privileged position with the programmes that we offer which support women to heal from the impact of adversity and abuse and build resilience for themselves and their children. Leaving is a process and healing is a process, change doesn't happen overnight. A consistent approach of a pathway of programmes that women can work their way through is what we have found to have the most positive approach in moving forward.

# **WOMEN'S PROGRAMMES**

We start with the delivery of the 11-week **Freedom Programme** which is open to women 16+ who want to learn more about the reality of domestic abuse in relationships. Each session explores the abusive tactics, controlling behaviours and belief systems of the dominator and the effects on women's health and well-being. This programme is run continuously so women can join at any week as each session stands on its own. Everyone who attends the programme receives a copy of 'Living with The Dominator' and The Home Study Workbook. We have between 30-39 women attending each week, the sessions use a one step removed approach so no one has to disclose anything about themselves. "Trauma-informed care does not require that the person disclose trauma. It means that care providers must use daily practices based on safety, choice and control, which are key to

empowering trauma survivors and making sure they are not re-traumatised" (Ref: Healthy Families: From ACEs to Trauma-informed Care to Resilience and Well-being).

A rolling programme 179 women attended

The **Recovery Toolkit** is a 12-week programme for any individual who has experienced domestic abuse, designed to assist to build confidence and self-esteem and look at ways to develop positive lifestyle coping strategies. It is unique in its approach using a combination of

psycho-education, trauma focused cognitive behaviour therapy and person-centered therapeutic principles. We delivered three programmes throughout the year attended by 52 women in total.

3 programmes delivered 52 women attended

You & Me, Mum Programme is an 11-week programme where mothers have the opportunity to safely explore the impact domestic abuse has had on themselves and the relationship with their children. It also explores Protective Behaviour messages and strategies for keeping safe. The course focuses on self-empowerment and mutual aid, recognising the central role of mothers in the protection and positive development of their children. We delivered two programmes throughout the year attended by 32 women in total.

2 programmes delivered 32 women attended This year we added The ACEs (Adverse Childhood Experiences) Recovery Toolkit to our

pathway. We were the first organisation in the UK to pilot it. It is a 10-week programme which has been developed to help understand the impact of childhood adversity on parents and their children. The programme offers guidance on protective factors that can help reduce the impact of ACEs and provides practical methods to

develop resilience. Sessions include: Understanding and living with ACEs; understanding toxic stress and strategies to manage it; developing parental resilience; understanding attachment & nurturing parenting styles; managing emotions and developing strategies to reduce the potential impact of ACEs on children. The ACEs toolkit promotes a recovery model described as HOPE, AGENCY and OPPORTUNITY.

The programmes use a trauma informed psycho educational model believing that by giving individuals knowledge we enable them to overcome the effects of their experiences and in doing so improve their emotional safety and well-being, reduce their risk of further harm and victimisation and heal from the impact of the abuse they have suffered and in doing so create the healing foundation for their children to heal. We have over the years shared our approach with many of the leading organisations; statutory, community, private, public and CICs and are proud to have been the first organisation in the City to put together the above model which we are starting to see replicated by other agencies.


# CHILDREN'S PROGRAMMES

# **Healing Together**

This year saw the start of a new three-year partnership with Innovating Minds. Thanks to our Reaching Communities grant Innovating Minds will provide the 'Healing Together' programme for children and young people impacted by domestic violence whilst their mothers attend programmes here. Psychologist Dr Asha Patel, CEO of Innovating Minds says 'We believe that children are more likely to have a successful recovery journey when their primary caregiver has started recovery'. The first programmes catered for 7-9 year olds and the current programme caters for 13-15-year olds. Feedback from mothers has been extremely positive especially as they are sharing in their healing through attending programmes themselves. Three programmes will take place each year for the next three years. We look forward to sharing more information in next year's annual report.

# Children's Recovery Toolkit

Beyond the Horizon delivered the Children's Recovery Toolkit programme. Five children took part with ages ranging from 7-9 years old. Again parents witnessed many positive outcomes and a sharing of experiences. Topics included: How abuse affects our thinking, Self-esteem-what is it? Who's my family? Talking positive; Ways to handle difficult feelings; and Healthy relationships and trust.



# **ACTIVITIES**

Funding from the Grimmit Trust, Birmingham Irish Cycle appeal and the Heart of England Community Foundation has enabled us to organise activities, workshops, events and weekly art and dance sessions. These are an invaluable part of the recovery process; re-establishing connections, building relationships, reducing isolation, building self-esteem and reducing isolation. A mixture of user led activities has increased the opportunities we can offer which make a real difference to the health and well-being of the women at our project. The weekly art sessions have produced some amazing paintings which we will be displaying later in the year.



Our weekly dance sessions are great fun, headed by a qualified dance instructor who has been taking everyone through their paces with the aim of performing 'Break the Chain' dance routine in Birmingham City Centre on February 14th 2019 for One Billion Rising. The sessions are fun, fabulous and freeing! We will be inviting other women's organisations in the West Midlands to join us for what will be a spectacular display of universal unity as we dance together with women around the world on the same day.

In July 2017 a group of 20 women attended the Community Spirit Event at Birmingham Symphony Hall. The concert brought together some of the best choirs and homegrown talent in the West Midlands for an evening of incredible choral music. We were taken on a journey through music and genres ranging from folk, to pop, classical and gospel. It was an extra special event as a woman attending our programmes was performing in one of the 11 choirs on the stage. We were there to support her and celebrate her freedom as she was now free to sing to her heart's content. We joined in the choruses and there were hugs aplenty at the end of the night. Another wonderful display of sisterhood, solidarity and support.

In October 2017 we were delighted to welcome MP Jess Phillips to give a talk about her book "Everywoman: One Women's Truth about Speaking the Truth" It was great to have our own private book talk especially for the women on our programmes. Jess talked about her previous role in domestic abuse at Sandwell Women's Aid, her role as an MP, her family,

female solidarity and her fight to make change in legislation. Thirty women attended and Jess stayed and chatted afterwards, signed books and answered many of the questions from the floor. It was wonderful experience and an insight into the life of a female MP.


In March 2018 we took a group of 15 women to the Drop the Disorder conference. This event was for everyone who is interested in the current debates around mental health attracting psychologists, counsellors, service users and psychiatrists. It was an inspiring, uplifting, thought provoking and hopeful day with many new friends made and a chance for women on our programmes to hear from the many inspirational speakers, many who were survivors themselves. Our attendance has led to two of the main speakers planning a visit to our project in July 2018; Psychotherapist, activist, trainer Jo Watson and Poet, author, trainer Clare Shaw.

**SOLICITORS Drop-In Sessions** are held at our base twice monthly thanks to Duncan Lewis and Silks Solicitors. This service has been invaluable, having easy access to legal advice in an environment where women feel safe and can gather information to make informed choices about their next step. Even today as I am writing this I have received the following text, 'Thanks so much for linking me with Sapphire, I'm in court today and I've just

been granted a non-molestation order'

University of Birmingham are currently undertaking a service evaluation of the project. The evaluation is being spearheaded by Caroline Bradbury-Jones who leads the Risk, Abuse and Violence Research Department, and Isobel Heywood a post-graduate student studying for a Masters in Public Health. The evaluation will gain qualitative insights into the perceived benefits of the programme to women who have attended (and consequently their children). Open invitations were advertised throughout our groups and 40 women agreed to take part. Isobel attended many events throughout the year to get to know the project and to be available should anyone have any further questions about the research. Initial findings have been completed and we are looking forward to the final outcome. We are delighted that Jess Phillips MP has agreed to host the launch of the research.

In March 2018 we attended the Young Minds Addressing Adversity Conference where we heard from an array of wonderful speakers including Betsy de Thiery, Warren Larkin and Anna Robinson. Following on from that conference we were invited to attend a community of practice event to share ideas, engage in discussions around best practice and to network with fellow professionals working within the children's workforce. From the original event five people attended and decided to take it further and arranged the first Childhood Adversity and Trauma Informed Care, Community of Practice meeting for the Midlands. We will be hosting

the first meeting in May 2018 which will include a screening of Resilience. The purpose at this beginning stage will be to share practice rather than working in isolation, to prioritise adversity and trauma-informed care and to increase collaborative working in the Midlands.

Another outcome from the original event is that staff and trustees attended a full day's training with Betsy de Thiery at the Trauma Recovery Centre in Bath. It was an awe inspiring day looking at trauma and complex trauma, the trauma continuum and trauma symptoms. If you haven't experienced Betsy's presentations, workshops or training days then you are missing out on a truly amazing learning experience.

During the year we had stalls at Birmingham Adults Safeguarding Event and Birmingham Children's Safeguarding Board Event. Both events included a wide range of agencies sharing information, resources and networking. We are a partner agency of the Adult Safeguarding Board and are signed up to the memorandum of understanding which shows a commitment to attend four board led events throughout the year which encourages dialogue between agencies and the board.

In March 2018 We were delighted to receive an invite from the Big Lottery Fund to present to the Gambling Commission about how our beneficiaries have benefited from Lottery funding. We met with Grant Baskerville Senior Head of Policy and Public Affairs and delivered a presentation about our project and the benefits to the women we support. After the event Grant contacted us to say, "The feedback we've had about the visit has been fantastic. The way you shared your own personal story and the transformational work you do with so many vulnerable women and children is incredible. Your passion and commitment to helping people was clear to see for everyone in the room" It was lovely to have the opportunity to share our work with funders and stakeholders and to hear how they appreciate the work we do.

# **CELEBRATION EVENTS**


We held two pamper events throughout the year as a way of celebrating completion of programmes and giving women the opportunity to sign up for follow on courses. At Christmas we held an event for women who had completed September - December programmes. It was a day of celebrating freedom, recovery, empowerment and connectedness. A wonderful feel good day with a range of therapeutic activities including, hairdressers, nail artists, sports massage, reiki, facials, waxing, threading and creative activities. Food, music, dancing, party

hats and a chorus of Christmas songs completed the day. Jess Phillips was the guest speaker and stayed for a good few hours chatting to women, taking part in activities and talking about her role as an MP. Following the event, the Christmas tree, lights and decorations were taken to the home of one of the women who was struggling to put Christmas together for her children. The joy of the children's faces was heart-warming. Also, thanks to Birmingham City Mission, B31 Sass and Marty Taylor and Morrisons Longbridge, we received bags full of toys to hand out to families. We also received presents for the women from Birmingham & Solihull CCG, University of Birmingham Women's Football Team and through local collections.

# **DEAR FRIEND LETTERS**

The **DEAR FRIEND** letters project is a creative way for women to write about their experiences of attending programmes. Each letter gives hope and encouragement to future potential participants who may be unsure about attending. It is also enables women to reflect on how far they have come in their journey. Thanks to the Heart of England Foundation, the collection will be added to over the next three years and created into a book and a video to promote, highlight and offer hope. The plan is to reach out to well-known women to be the voice and face of the letter writers. Our first letter reader to be filmed is Katharine Perry a Child Development Consultant. As Katherine says in the video she was delighted to read the letter especially as the writer was positively influenced by her father, the renowned psychiatrist and Senior Fellow of the Child Trauma Academy, Dr Bruce Perry. Further video recordings will be filmed and released on social media over the next few weeks including Birmingham MP Jess Phillips and radio presenters Charlie Jordan from smooth Radio, Matilda New from Capitol Radio, comedian Janice Connolly (AKA Barbara Nice) and many more to be announced.

The letters and videos will culminate in a short film and a booklet. The project is being led by our Office Administrator Jo Willis and filmed by Producer-Director Sho Bhatia.



# **GDPR**

Being informed and empowered enables women to not only survive but go on to thrive and create a new life for themselves and their children. Healing occurs in the safe home, when the mother heals she can then create the ultimate healing foundation for the child. Healing of the child cannot be done in isolation.

This year has seen two women starting their first year at University both after completing our programmes. Both had experienced domestic abuse and had children's services involvement and now want to use their journey as an example to others that there is hope after adversity, that our past does not have to predict our future and that with the right support we can heal, reclaim and regain. We look forward to attending their graduation and sharing in their success.

We have also seen mothers and children reunited from the care of the local authority. Jane\* started attending the Freedom Programme when her two sons were taken into care due to witnessing domestic abuse. With no family support and feeling isolated she was desperate to find support which would help her understand the court process, engage with the many agencies involved, build her confidence and self-esteem and rebuild her role as a mother. After working through the programmes Jane\* was able to present her case, work effectively with the agencies and has recently been reunited with her children. When she received the news she came into the group armed with cakes for everyone and there was tears of joy and sisterly hugs all round.

Ameena\* was in the same situation, having suffered many years of domestic abuse and too scared to tell anyone. Her two daughters had been taken into the care of the local authority. When her solicitor gave her our number it was the start of the process of working her way through the system but this time with hope, support and by the final hearing a new toolbox of strategies which gave her the outcome she so deserved; to be reunited with her children.

We feel very privileged to be a part of the healing process of the families who attend our programmes. The successful outcomes that we witness each and every week teach us that with the right support, domestic abuse does not have to mean a life sentence for women and children, and that recovery and healing is possible. With knowledge, awareness and empowerment the past does not have to predict the future, especially when you no longer live there. Adverse Childhood Experiences are not a destiny, what's predictable is preventable in the next generation and what's shareable is bearable.

Regaining control and reclaiming oneself is a process and takes time. Leaving and recovering from the abusive relationship is not easy or straightforward, but with safe, appropriate and timely support, new and better lives, free from violence, can be built. Through a trauma informed approach, understanding the needs of the women who attend, ensuring activities are planned alongside participants, a warm welcome, refreshments, the right resources and consistency of delivery, we are hopeful that women's needs will be met and they can reclaim their lives and be the women, mothers, daughters and sisters they were born to be.
