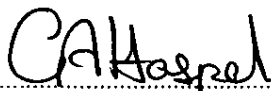

1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

The company was dormant throughout the period ended 30 April 2009.

2. CALLED UP SHARE CAPITAL

The company has no share capital but is limited by the guarantee of its members to the extent of £10 each.
