**Trustees' Annual Report** 

The Trustees present their annual report and accounts for the year ended 31 December 2019. The Trustees' Annual Report is also the Directors' report for the purposes of Company Law. The Directors of the charitable company ("the charity") are its trustees for the purposes of charity law and throughout this report are collectively referred to as the Trustees.

#### INTRODUCTION

The Steve Sinnott Foundation holds the vision that all children have the right to quality education, and we work with partners to ensure that this becomes a reality. We support the achievement of the United Nations Sustainable Development Goals, specifically SDG 4 which calls for universal access to quality education that is inclusive and equitable and for the promotion of lifelong learning opportunities. At the Foundation, we are proud to work toward making this goal a reality.

We are now in our 10th year of operation and we are continually learning ourselves as an organisation. We work with teachers and educators on the ground to develop projects that are "fit for purpose", locally owned and managed and sustainable. In 2019 we have mostly focused our efforts in Sierra Leone, Nepal, Haiti and The Gambia.

The Foundation was established in 2009 to maintain the momentum of the work of Steve Sinnott, General Secretary of the National Union of Teachers of England and Wales, in promoting the achievement of the United Nations Millennium Development Goals for Education established by world leaders in 2000. Steve died suddenly, whilst still in office, in April 2008.

In 2015 world leaders met again to renew their commitment and agreed 17 "Sustainable Development Goals" (SDGs) with a target date of 2030 for their achievement. The declared objective is to end poverty, protect the planet and ensure that all people enjoy peace and prosperity. SDG4 is to ensure inclusive and equitable quality education and promote lifelong learning opportunities for all.

#### **OBJECTIVES AND ACTIVITIES**

The Charity's objects (the Objects) are to promote for the public benefit the education of children and young people across the world by seeking to ensure access to a full course of primary education for all boys and girls in accordance with the United Nations Millennium Development Goal 2 and these Objects may be advanced by any of the following means:

- a) improving the ability of teachers across the world to collaborate in improving the access to and quality of education for all children;
- b) providing a focus for ideas from educators around the world as to how universal primary education may best be achieved and collecting and disseminating these ideas;
- c) establishing an online international community of teachers, educationalists and other interested parties to discuss ideas for advancing universal primary education; and
- d) supporting projects for the development of education in developing countries and encouraging the participation of teachers and educationalists from the developed world in such projects.

The charity's principal activities are to raise funds and provide funding and develop partnerships for the delivery of sustainable projects to improve education in in developing countries working with teachers and educators from across the world.

The Trustees confirm that they have had regard to the guidance issued by the Charity Commission on public benefit.

#### **ACHIEVEMENTS AND PERFORMANCE**

#### SSF Partner Projects

We work with teachers and educators on the ground to develop projects that are "fit for purpose", are locally owned and managed and also sustainable. In recent years we have mostly focused our efforts in Sierra Leone, Nepal, Haiti and The Gambia. Here is a selection of our current work:

In Sierra Leone and The Gambia: Girls are missing 50 days of school each year just because they have their period. The Sanitary Protection Project training now named "Positive Periods" teaches girls and young women about good menstrual health and how to take care of their bodies alongside creating their own re-usable sanitary pads which are long lasting, locally sourced, and most importantly, eco-friendly.

Teachers from The Gambia are now replicating this work and training teachers in Sierra Leone. So far, we have supported over 80,000 girls and young women to attend school and work every day and participate in daily life with dignity and pride as well as accessing education.

In Haiti: we are continuing our support to 260 teachers to study for their teaching qualification and these teachers will impact on the lives of more than 26,000 students by providing quality education. Due to the learning resource centre being located in a red zone and the current political climate in Haiti, we have started to look at relocating the learning resource centre.

In Nepal: we have invested in developing a Learning Resource Centre that provides ideal learning conditions for both students and teachers and we are pleased that the centre has been used to full capacity this year and has been doing outreach work to rural schools as well as working with schools within Tansen.

In these centres students have access to books as well as electronic equipment, musical instruments, science and robotic kits and art materials to facilitate their learning. So far, over 2,000 students and teachers have benefited from the LRCs.

In The Gambia: In addition to the Positive Periods programme, we supported the delivery of gender pedagogy training and we have begun scoping a Learning Resource Centre, which will open in Spring 2020. We also entered into a partnership with Book Aid International and Gambia Teachers Union to provide 1,000 books and librarian training for the learning resource centre and this was delivered in August 2019.

Global Learning: The "My Life Changed" storytelling project has gone from strength to strength and the resource packs have been delivered to over 1,000 schools in the U.K and Internationally. The resource pack was developed with the support of National Union of Teachers Young Teachers Group and The Gambia Teachers Union amongst others. The Foundation has delivered creative workshops that teach students about the art of storytelling and how to do it effectively. Storytelling has proven to have many benefits for both young children and adults that include improving their vocabulary, encouraging the use of imagination and creativity, developing communication skills such as listening and empathy, and most importantly, it can help those who are dealing with difficult situations and problems.

We facilitated several workshops at the National Education Union Conference in April 2019, at Education International Conference in Thailand in August 2019 and at the UNESCO ASPnet Conference in UAE in September 2019. In partnership with The Literacy Project, we facilitated the screenings of "Maestra" in Haitian Kreyol and workshops for students and teachers on the Importance of 'Learning in Mother Tongue' in Haiti in September 2019 to coincide with World Literacy day.

#### **Steve Sinnott Young Ambassadors GCE**

In 2008, following Steve Sinnott's death, a fund was established to support a scheme in which students in UK schools would enter an annual competition to become "Steve Sinnott Young Ambassadors" for the Send My Friend to School campaign run by the Global Campaign for Education in the UK (GCE). The winners of the competition then travelled with the sponsoring charity for the year to one of the countries in which that charity works and then, back in the UK acted as ambassadors for the GCE at Conference, Parliamentary Party Conferences and other events taking place during the year.

In 2017, we turned the award on its head and choose now to offer this opportunity to young campaigners in other countries to have an opportunity to visit the UK, attend party conferences and share their experiences with young people in Britain and return home to continue to campaign for the right to education.

Two young students, Jessy Nkhoma and Isaac Mzembe from Malawi visited the UK in the autumn of 2019 hosted by Oxfam and supported by the Foundation and GCE UK. They were able to join delegates at the Conservative Party Conference, visit schools and participate in several educational and cultural activities during their visit.

#### **UNESCO ASPnet Schools Programme**

The Foundation's Chief Executive, Ann Beatty is the UK Co-ordinator for UNESCO's ASPnet programme. This is a is a global network of over 10,000 educational institutions in 182 countries. Member institutions - ranging from pre-schools, primary, secondary and vocational schools to teacher training institutions - work in support of international understanding, peace, intercultural dialogue, sustainable development and quality education in practice.

In her capacity as the UK Unesco ASPnet co-ordinator, the Foundation's Chief Executive hosted students from UNESCO ASPnet schools in Russia and represented the U.K National Commission at a Sustainable Development Gaols Conference in the UAE in September 2019. We continued throughout 2019 in efforts to increase the number of ASPnet participating schools in the UK.

# Sustainability and fundraising project

The Foundation was awarded a grant from KEEP + through Anglia Ruskin University in November 2018 to work on a sustainability plan for the Foundation. Adverts were placed to carry out this work during November 2018 and Hertfordshire University was successful in being selected as a partner for this project. Luis da Silva was employed as a Business Development Associate in January 2019 and worked on researching and developing a Sustainability plan for the Foundation. The Foundation will continue to develop a plan from the pilot in partnership with the University of Hertfordshire in 2020.

#### **ENGAGE** – the Foundation magazine

The Foundation published the nineteenth and twentieth issues of its magazine, ENGAGE which again attracted high profile contributors of articles published alongside project reports, news updates from around the world together with articles from international development activists, teachers and students and news about the Foundation's activities.

## Future plans

In the future will be focussing on projects which provide access to education for all children everywhere: Leaning Resource Centres, Teacher Training, Girls Educaiton, Connectivity and Sustainability.

## FINANCIAL REVIEW AND RESERVES POLICY

The Foundation's income in 2019 was again derived almost entirely from donations.

The Teachers Group Educational Trust agreed to grant £100,000 in each of the years 2020, 2021, 2022, 2023 and 2024.

The National Education Union granted £50,000.

The Foundation received 2 legacies, one in 2018 and a further one in 2019 totalling £57k. The trustees agreed at a meeting in October 2018 to invest funds from legacies with the intention of earning interest on funds not currently required for the day to day running of the charity. The amount invested at 31 December 2019 is set out in note 6 of the accounts.

The Trustees wish to maintain reserves equal to 12 months of operating costs and if reserves fell below this level, a meeting of the trustees would be held to agree appropriate action. This reserves policy currently reflects a minimum level of reserves of circa £70,000.

The company held reserves of £145,216 at 31 December 2019 (2018; £196,735) comprising unrestricted funds as set out in note 11 of the accounts. The level of reserves is above the minimum level of reserves of circa £70,000 for the current year required under the agreed reserves policy. Reserves have fallen during the year mainly due to expenditure during the year on the sustainability project and the Positive Periods project and research.

#### STRUCTURE, GOVERNANCE AND MANAGEMENT

The organisation is governed by the Memorandum and Articles of Association agreed in 2015.

Ann Beatty continued as the Foundation's Chief Executive throughout 2019.

#### 1 Accounting policies

#### Basis of preparation

The accounts have been prepared under the historical cost convention and in accordance with the Statement of Recommended Practice (SORP), Accounting and Reporting by Charities and FRS 102, The Financial Reporting Standard applicable in the UK and Republic of Ireland (as applied to small entities by section 1A of the standard) and the Companies Act 2006.

The Steve Sinnott Foundation meets the definition of a public benefit entity under FRS 102.

#### Alternative reporting

Income and expenditure have been analysed on a natural basis, taking advantage of sections 4.17 and 4.18 of the SORP.

#### Departure from the Charities (Accounts and Reports) Regulations 2008

The financial statements have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair view'. This departure has involved following SORP 2015 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 (SORP 2005) which has since been withdrawn.

#### **Fund Accounting**

Funds held by the charity are either:

Unrestricted funds are available for the use at the discretion of the trustees in furtherance of the general objectives of the charity.

Designated funds are unrestricted funds earmarked by the trustees for a particular purpose.

Restricted funds are subject to restrictions on their expenditure imposed by the donor or through the terms of appeal.

## Income

Income received from subscriptions, donations, Gift Aid Tax and activities is measured at the fair value of the consideration received or receivable. Income is recognised when the charity has entitlement to the funds, any performance conditions attached the item of income have been met, it is probable that the income will be received and the amount can be reliably measured. Accruals are made for monies received on fund generating activities that were held during the financial year but received after the financial year end up to the date these financial statements were approved by the trustee/directors. Income received in advance of the provision of services is deferred until the criteria for income recognition are met.

#### Expenditure

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable tht a settlement will be required and the amount of the obligation can be measured reliably. Resources expended are included in the Statements of Financial Activities on an accrual basis, inclusive of any VAT which cannot be recovered. Where applicable they have been charged directly to the funds and activities to which they relate.

#### Tangible fixed assets

Tangible fixed assets are measured at cost less accumulative depreciation and any accumulative impairment losses. Depreciation is provided on all tangible fixed assets, other than freehold land, at rates calculated to write off the cost, less estimated residual value, of each asset evenly over its expected useful life, as follows:

Plant and machinery

over 4 years

#### Current asset investments

Listed investments are measured at fair value. Unlisted investments are measured at fair value unless the value cannot be measured reliably, in which case they are measured at cost less any accumulated impairment losses. Changes in fair value are included in the income and expenditure account.

#### **Debtors**

Short term debtors are measured at transaction price (which is usually the invoice price), less any impairment losses for bad and doubtful debts. Loans and other financial assets are initially recognised at transaction price including any transaction costs and subsequently measured at amortised cost determined using the effective interest method, less any impairment losses for bad and doubtful debts.

#### **Creditors**

Short term creditors are measured at transaction price (which is usually the invoice price). Loans and other financial liabilities are initially recognised at transaction price net of any transaction costs and subsequently measured at amortised cost determined using the effective interest method.

#### **Pensions**

Contributions to defined contribution plans are expensed in the period to which they relate.
