UPON THE APPLICATION of the Applicant filed on 27 September 2018

AND UPON READING:

- (1) the Witness Statement of Gerard Anthony Friar dated 27 September 2018 and Exhibit GAF1;
- (2) the written consent of the replacement office-holders, namely Alistair McAlinden dated 19 September 2018; and Mark Orton dated 25 September 2018; and
- (3) the written consent of the person who currently holds office with the Applicant, namely Blair Carnegie Nimmo dated 25 September 2018 is also filed herein.

IT IS ORDERED THAT:

- 1. The cases numbered 1 to 2 in Schedule 1 be transferred to the High Court of Justice, Chancery Division for the purpose only of making this order.
- 2. Immediately upon this application being dealt with by the court, the cases transferred pursuant to paragraph 1 be transferred back to the court from which it was transferred.
- 3. In relation to the appointments set out in Schedule 1 hereto, Gerard Anthony Friar be removed and Alistair McAlinden be appointed as his replacement with the remaining office-holder for each case as detailed in the said Schedule 1 continuing as office-holder in respect of the appointments.
- 4. In relation to the appointments set out in Schedule 2 hereto, Gerard Anthony Friar be removed and Mark Orton be appointed as his replacement with the remaining office-holder as detailed in the said Schedule 2 continuing as office-holder in respect of the appointments.
- 5. That the creditors or members in each case be notified of any order made under this application by advertisement in the London Gazette within 14 days and at the time of the next statutory reporting requirement for each case,
- 6. Any creditor or, in the case of any members' voluntary liquidation, any member in respect of any of the companies listed in Schedules 1 to 2 who has an objection to this order shall have 28 days from the date of advertisement in the London Gazette to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in Schedules 1 to 2 until further or other order by the court.
- 7. The outgoing officeholder shall file a copy of this order with each of the courts listed in Schedules 1 to 2.
- 8. The outgoing officeholder shall serve a copy of this order on the Secretary of State.
- 9. That the costs of making this application shall be apportioned equally amongst the 10 cases listed in Schedules 1 to 2 hereto and that:
- (i) where the case relates to an administration appointment, the pro rata share of the cost of this application shall be payable as an expense of the administration as the Applicant is one of the current administrators; and
- (ii) where the case relates to any insolvency proceeding other than administration, the pro rata share of the cost of this application shall be payable as an expense of the insolvency proceedings as in the circumstances, this application is necessary and the most cost-effective method of replacing the outgoing office-holder and the cost per case is expected to be approximately £350.
- 10. Such further or other relief as the Honourable Court shall consider just.
