Upon reading the application made by the Applicant and the witness statement of Kerry Pearson

It is ordered that

1. Each of the County Court cases listed in the Schedule attached to this order (Schedule) be transferred to the High Court of Justice, Chancery Division, Business and Property Courts in Newcastle upon Tyne, Insolvency and Companies List for the purpose only of making this order.

- 2. Immediately upon this order taking effect, the County Court cases listed in the Schedule be transferred back to the County Court.
- 3. Iain David Nairn be removed from office in respect of each of the cases listed in Part A, Part B and Part C of the Schedule from the date of this order.
- 4. Andrew Little be removed from office in respect of each of the cases listed in Part C, Part D, Part E, Part F and Part H of the Schedule from the date of this order.
- 5. Kerry Pearson be appointed as joint replacement office-holder in respect of each of the block transfer cases listed in Part A and Part D of the Schedule from the date of this order.
- Margaret Carter be appointed as joint replacement office-holder in respect of each of the block transfer cases listed in Part B, Part C and Part E of the Schedule from the date of this order.
- 7. Nicola Clark be appointed as joint replacement office-holder in respect of the case listed in Part F of the Schedule from the date of this order.
- 8. The outgoing office-holders shall file and serve a copy of the Order on each of the respective courts shown in the Schedule.
- 9. The creditors in each of the block transfer cases listed in the Schedule be notified of the removal and appointments made by this Order at the same time as the next report as required by law is made to the creditors.
