

GlobalEd is pro actively involved in the development implementation and promotion of educational programmes relating to the complex subject of sustainable development principally in Peru and the UK including projects materials, teacher training school links teacher exchanges internships school visits, funding initiatives and conference planning.

A focus of GlobalEd's work in 2010 was strengthening the capacity in Peru of mechanisms important in the implementation of Education for Sustainable Development (ESD). Important developments influences and contributions were made with organisational capacity building in 2010.

Notable successes have been GlobalEd's influence and support in the development of an internationally recognised Centre of Expertise in ESD for Peru's capital giving Lima for the 1st time a dedicated think tank on the concepts, mechanisms and implementation of ESD. Equally successful has been GlobalEd's support of the network of British International schools in Latin America who have embarked on their complex journey of developing ESD.

Continued overall benefit has been brought to the educational communities in both Peru and the UK in the execution of initiatives developed and supported by GlobalEd. A particularly appropriate programme of links between schools has seen an important step in 2010 with our 1st schools linking and learning about each other's lives inspired by their learning about renewable energies. Knock on benefits to the Peruvian school communities have been the installation of solar energy devices in the schools.

Developing initiatives with UK organisations facilitating UK school expeditions to Peru have been further developed in 2010 bringing huge benefit to those visiting from the UK and to those communities visited whilst in Peru related to this has been the continued support by GlobalEd of school linking and teacher exchange programmes.

By focusing on organisational capacity building in both Peru and the UK GlobalEd was able to advance its influence and support throughout both countries in 2010. This is important as GlobalEd is essentially taking on the role of educational support in all its forms in the development of ESD and the Global Dimension in both country's formal education programmes. Stimulating the educational community in Peru to embrace ESD in this way gives us a firmer base to be developing our work and supporting that of others.

In 2010 GlobalEd's focus on organisational capacity building involved a significant amount of consultation with stakeholders in each initiative. That process of consultation is evident in the successes we have had in the development, implementation and execution of initiatives in 2010. GlobalEd recognises from experience that the consultation process is vital if programmes are to be appropriate to the beneficiaries and in themselves are sustainable.

An important feature of GlobalEd's work is enabling 'budget deficient' school communities to realise progressive and appropriate activities with innovative ways of sustaining implementation by considering new ways at resourcing initiatives.

GlobalEd's activities continue to service the needs of both educational communities in the UK and Peru. GlobalEd considers that its work should be triggered by the need and enquiry from a community, thereby giving support to them as opposed to the community supporting a 'development project' being promoted by an organisation such as GlobalEd.

GlobalEd also focused in 2010 on the technological facilities and skills of teachers in Peru to be able to communicate with better efficiency with partner schools in the UK. Particular emphasis was given to 'video conferencing' activities both between staff and classrooms. This has been a particularly prominent need identified by partner schools and organisations in Peru.


