ORDER

UPON the Application for a block transfer order dated 13 April 2021

AND UPON READING the evidence filed

IT IS ORDERED THAT:

1. Each of the High Court cases listed in the Schedule (attached to this Order) (the **Block Transfer Cases**) be transferred to the High Court of Justice, Chancery Division, Business and Property Courts in Leeds for the purpose only of making this Order.
2. Immediately upon this Order taking effect, the Block Transfer Cases be transferred back to their original location of High Court.
3. Nigel Ian Fox (the **Outgoing Officeholder**) be removed from office in respect of each of the Block Transfer Cases from the date of this Order pursuant to Rule 12.37(2) of the Insolvency (England and Wales) Rules 2016 (the **Rules**) without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Insolvency Act 1986 (as amended) (the **Act**) or the Rules for the insolvency cases listed in the Schedule (ii) apply to the Secretary of State for release or discharge pursuant to the Act or (iii) file a receipts and payments account.
4. Andrew Nalliah, Duncan Lyle, Richard Patrick Brewer and Matthew Wild (the **Replacement Officeholders**) be appointed as replacement officeholders in respect of each of the relevant Block Transfer Cases as listed in the Schedule (attached to this Order) from the date of this Order pursuant to Rule 12.37(3) of the Rules without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the Block Transfer Cases (ii) apply to the Secretary of State for release or discharge pursuant to the Act or (iii) file a receipts and payments account.
5. The Outgoing Officeholder be removed as joint officeholder on certain bankruptcy cases listed in the Block Transfer Cases without appointing a replacement joint office holder pursuant Rule 12.37(2) of the Rules and without being required to (i) use one of the decision procedures or deemed consent procedure set out in the Rules (ii) apply to the Secretary of State for release or discharge pursuant to the Act or (iii) file a receipts and payments account.

6. The creditors or, in the case of any members' voluntary liquidation, any member in each of the Block Transfer Cases except those creditors of the Individual Voluntary Arrangement, will, as required by the Rules, be notified of this Order by way of one composite advertisement published in the London Gazette (the **Advertisement**) within 14 days of receipt of the sealed Order from the Court and at the time of the next statutory reporting required for each of the Block Transfer Cases. Creditors of the Individual Voluntary Arrangement listed in Schedule (attached to this Order) shall be notified in writing of this order within 14 days of receipt of the sealed order.
7. Any creditor or, in the case of any members' voluntary liquidation, any member in respect of any of the companies or persons listed in the Block Transfer Cases who has an objection to this Order shall have 28 days from the date of the Advertisement, or date of deemed receipt of written notification, referred to at paragraph 6 to apply to Court to set aside or vary the terms of this Order. Such application shall not affect the transfer of the Block Transfer Cases until further or other Order by the Court.
8. The Outgoing Officeholder and the Replacement Officeholders (where applicable and as required by the Rules) shall deliver to the Secretary of State (Insolvency Service), notice of their appointment as soon as reasonably practicable.
9. The Outgoing Officeholder shall file a copy of this Order with each of the Courts listed in the Schedule (attached to this Order) where applicable.
10. Nothing in this Order shall release the Outgoing Officeholder from any obligation to give and file notices at Companies House in respect of his removal under this Order in respect of the Block Transfer Cases.
11. The Outgoing Officeholder shall receive his release as Liquidator, Supervisor or Trustee (as appropriate) 28 days after giving of notice to creditors in accordance with paragraph 6, save that such release may be subject to further Order in the event of an application by any creditor or member under paragraph 7 of this Order for the specific case subject to that application.
12. Where there are joint office holders appointed on the Block Transfer Cases, they will act jointly and severally in relation to all matters relating to the administration of the Block Transfer Cases.

13. The parties have liberty to apply to the court to amend this Order to include any appointments held by the Applicant which have been inadvertently omitted from the Application.
14. The terms of the order shall not apply to any case which is listed in the Block Transfer Cases, but which, prior to the order being made, is concluded and the case closed.
15. Such further order or other relief or direction as the court shall deem fit.
16. The costs of the Application (including VAT) shall be met by RSM Restructuring Advisory LLP.


