The directors have pleasure in presenting their report and accounts for the year ended 31st August 2018

Structure, governance and management

The organisation is a charitable company limited by guarantee, incorporated on 7th August 2009 and registered as a charity on 1st September 2009.

The company was established under a Memorandum of Association which established the objects and powers of the charity and is governed under its Articles of Association.

The directors, who are the trustees for the purpose of charity law, who served during the year and up to the date of this report are set out on page 1.

Objects

The objects of the charity are:-

to benefit all age groups with mobility-related disabilities by providing them with mobility equipment, information and advice to enhance the quality of their lives and to improve their opportunities to integrate into mainstream society.

Financial review

Total incoming resources for the year amounted to £9,750 (2017 - £9,750), with total resources expended of £73 (2017 - £73), resulting in net incoming resources of £9,677 (2017 - £9,677).

This report has been prepared in accordance with the Statement of Recommended Practice - Accounting and Reporting by Charities (FRS 102), taking advantage of the concessions provided by the SORP for smaller charities, and in accordance with the provisions for small companies under Part 15 of the Companies Act 2006.

1. ACCOUNTING POLICIES

Basis of accounting

The accounts have been prepared under the historical cost convention and in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006 and follow the recommendations in *Accounting and Reporting by Charities : Statement of Recommended Practice* (SORP FRS 102), taking advantage of the concessions provided by the SORP for smaller charities.

Incoming resources

All incoming resources are included in the Statement of Financial Activities when the charity becomes entitled to the resources, the directors are virtually certain they will receive the resources and the monetary value can be measured with sufficient reliability.

Expenditure and liabilities

Resources expended are recognised in the period in which they are incurred. Resources expended include attributable VAT which cannot be recovered.

Fund accounting

Unrestricted funds are donations and other incoming resources receivable or generated for the objects of the charity without further specified purpose and are available as general funds.

Designated funds are unrestricted funds earmarked by the directors for particular purposes.

Restricted funds are to be used for specific purposes as laid down by the donor. Expenditure which meets this criteria is charged to the fund.
