

Second Supplemental Debenture

THE SECOND SUPPLEMENTAL DEBENTURE is made on 4 February 2022

Between:

- 1 The entities listed in Schedule 1 (each a "Chargor" and together the "Chargors"); and
- 2 Silicon Valley Bank a California corporation operating through its UK branch, Alphabet, 14-18 Finsbury Square, London EC2A 1BR (the "Bank").

Background

- (A) Pursuant to the Original Debenture and the First Supplemental Debenture (each as defined below), each Chargor created Security Interests over all of its assets for, amongst other things, its present and future obligations and liabilities under the Loan Documents.
- (B) Secret Escapes Limited, in its capacity as Obligors' Agent, intends to enter into the Third Amendment and Restatement Agreement (as defined below) relating to the Loan Agreement (as defined below).
- (C) It is a condition precedent to the Third Amendment and Restatement Agreement that the Chargors enter into this Second Supplemental Debenture.
- (D) This Second Supplemental Debenture is supplemental to the Original Debenture and the First Supplemental Debenture (each as defined below).

The parties to this Second Supplemental Debenture agree as follows:

1 Definitions and Construction

1.1 Definitions

Terms defined in the Original Debenture shall, unless otherwise defined in this Second Supplemental Debenture or unless a contrary intention appears, bear the same meaning when used in this Second Supplemental Debenture and the following terms have the following meanings:

"First Amendment and Restatement Agreement" means the amendment and restatement agreement dated 4 February 2019 made between, among others, (1) Secret Escapes Limited and (2) the Bank.

"First Supplemental Debenture" means the supplemental debenture made between (1) the Chargors and (2) the Bank dated 4 February 2018.

"Liabilities" means all present and future liabilities and obligations of each Obligor to the Bank under the Loan Documents (including, without limitation, the Obligations), both actual and contingent and whether incurred solely or jointly or as principal or surety or in any other capacity together with any of the following matters relating to or arising in respect of those liabilities and obligations:

- (a) any refinancing, novation, deferral or extension;
- (b) any claim for breach of representation, warranty or undertaking or on an event of default or under any indemnity given under or in connection with any documents or agreement evidencing or constituting any other liability or obligation falling within this definition;
- (c) any claim for damages or restitution; and
- (d) any claim as a result of any recovery by any Obligor of a Payment on the grounds or preference or otherwise,

and any amounts which would be included in any of the above but for any discharge, non-provability, unenforceability or non-allowance of those amounts in any insolvency or other proceedings.

"Loan Agreement" means the loan agreement originally dated 11 October 2017 and made between inter alia, the Chargors and the Bank, as amended from time to time and as amended and restated pursuant to the terms of the First Amendment and

Restatement Agreement, the Second Amendment and Restatement Agreement and the Third Amendment and Restatement Agreement.

"**Loan Document**" has the meaning given to that term in the Loan Agreement.

"**Original Debenture**" means the debenture between (1) the Chargors and (2) the Bank dated 12 October 2017.

"**Second Amendment and Restatement Agreement**" means the second amendment and restatement agreement dated 11 May 2020 made between, among others, (1) Secret Escapes Limited and (2) the Bank.

"**Secured Liabilities**" means all Liabilities and all other present and future liabilities and obligations at any time due, owing or incurred by each Obligor to the Bank under each Loan Document (as amended and/or amended and restated from time to time including, in respect of the Loan Agreement, pursuant to the terms of the Third Amendment and Restatement Agreement), both actual and contingent and whether incurred solely or jointly and whether as principal or surety or in any other capacity.

"**Third Amendment and Restatement Agreement**" means the amendment and restatement agreement dated on or around the date of this Second Supplemental Debenture and made between (1) Secret Escapes Limited and (2) the Bank.

1.2 Construction

- (a) Unless a contrary intention appears, Clause 1.2 (*Construction*) of the Original Debenture applies to this Second Supplemental Debenture, and shall be deemed to be incorporated into this Second Supplemental Debenture, mutatis mutandis, as though set out in full in this Second Supplemental Debenture, with any reference to "**this Agreement**" being deemed to be a reference to "**this Second Supplemental Debenture**", subject to any necessary changes.
- (b) Any references to the Bank or any Receiver shall include its Delegate.

1.3 Law of Property (Miscellaneous Provisions) Act 1989

To the extent necessary for any agreement for the disposition of the Security Assets in this Second Supplemental Debenture to be a valid agreement under section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989, the terms of the other Loan Documents and of any side letters between the parties to this Second Supplemental Debenture are incorporated into this Second Supplemental Debenture.

1.4 Implied Covenants for Title

The obligations of the Chargors under this Second Supplemental Debenture shall be in addition to the covenants for title deemed to be included in this Second Supplemental Debenture by virtue of Part I of the Law of Property (Miscellaneous Provisions) Act 1994.

1.5 Effect as a Deed

This Second Supplemental Debenture is intended to take effect as a deed notwithstanding that the Bank may have executed it under hand only.

2. Covenant to Pay

Each Chargor as primary obligor covenants with the Bank that it will on demand pay to the Bank the Secured Liabilities when the same fall due for payment.

3. Security Assets

3.1 Fixed Charges

- (a) Each Chargor, as security for the payment discharge and performance of the Secured Liabilities, charges in favour of the Bank, with full title guarantee, the following assets, from time to time owned by it or in which it has an interest:
 - (i) by way of first legal mortgage, each Property legal title to which is vested in it on the date of this Second Supplemental Debenture; and
 - (ii) by way of first fixed charge;

- (A) all Property not effectively mortgaged under Clause (a)(i);
- (B) all Plant and Machinery;
- (C) all Shares specified in Part 3 of Schedule 2 (*Security Assets*);
- (D) all Investments other than the Shares;
- (E) all Receivables directed to be paid into the SVB Operating Accounts;
- (F) all Receivables directed to be paid into the Third Party Accounts;
- (G) the SVB Operating Accounts;
- (H) the Third Party Accounts, other than the Excluded Deposits;
- (I) all Intellectual Property specified in Part 2 of Schedule 2 (*Security Assets*);
- (J) all other Intellectual Property; and
- (K) its goodwill and uncalled capital.

3.2 Security Assignment

As further security for the payment of the Secured Liabilities, each Chargor assigns, by way of security, with full title guarantee to the Bank all its rights, title and interest in:

- (a) the Insurances and the Insurance Proceeds;
- (b) all Related Rights in respect of each of the above,

subject in each case to reassignment by the bank to the relevant Chargor of all such rights, title and interest upon payment or discharge in full of the Secured Liabilities.

3.3 Floating Charge

- (a) As further security for the payment, discharge and performance of the Secured Liabilities, each Chargor charges with full title guarantee in favour of the Bank by way of first floating charge:
 - (i) the Excluded Deposits; and
 - (ii) its undertaking and all its present and future assets other than those assets which are effectively charged by way of first fixed charge or legal mortgage under Clause 3 (*Fixed Charges*) or which are effectively assigned by way of security under Clause 3.2 (*Security Assignment*).
- (b) Paragraph 14 of Schedule B1 to the Insolvency Act 1986 shall apply to the floating charge created by this Second Supplemental Debenture.

3.4 Conversion of Floating Charge by Notice

If:

- (a) the security constituted by this Second Supplemental Debenture has become enforceable; or
- (b) the Bank is of the view that any legal process or execution is being enforced against any Floating Charge Asset or (acting reasonably) that any Floating Charge Asset is in danger of being seized, sold or otherwise in jeopardy,

the Bank may, by written notice to a Chargor, convert the floating charge created under this Second Supplemental Debenture into a fixed charge as regards those assets which it specifies in that notice. The relevant Chargor shall promptly following request by the Bank execute a fixed charge or legal or equitable assignment over those assets in such form as the Bank may require.

3.5 Automatic Conversion of Floating Charge

If, without the prior written consent of the Bank:

- (a) a Chargor creates any Security Interest (other than a Permitted Security Interest) over all or any of the Security Assets or attempts to do so;
- (b) any person levies or attempts to levy any attachment, execution or other legal process against any of such Security Assets;
- (c) a resolution is passed or an order is made for the winding up, dissolution, administration or other reorganisation of a Chargor; or
- (d) any steps are taken for the appointment of, or notice is given of intention to appoint, or a petition is filed or application is made, or a competent court makes an order for the appointment of an administrator, in relation to a Chargor,

then the floating charge created by this Second Supplemental Debenture over the Floating Charge Assets of that Chargor will automatically, without notice, be converted into a fixed charge as soon as such event occurs.

3.6 **Part A1 moratorium**

- (a) Subject to paragraph (a) below, the obtaining of a moratorium under Part A1 of the Insolvency Act 1986, or anything done with a view to obtaining such a moratorium (including any preliminary decision or investigation), shall not be an event causing any floating charge created by this Deed to crystallise or causing restrictions which would not otherwise apply to be imposed on the disposal of any asset by a Chargor or a ground for the appointment of a Receiver.
- (b) Paragraph (a) above does not apply in respect of any floating charge referred to in subsection (4) of section A52 of Part A1 of the Insolvency Act 1986.

4 **Incorporation**

The provisions of Clause 4 (*Nature of Security*) to Clause 19 (*Miscellaneous*) (inclusive) of the Original Debenture apply to this Second Supplemental Debenture as though they were set out in full in this Second Supplemental Debenture except that references to "this Deed" in the Original Debenture are to be construed as references to "**this Second Supplemental Debenture**".

5 **Continuation**

- 5.1 Except insofar as supplemental hereby, the Original Debenture will remain in full force and effect.
- 5.2 Each Chargor agrees that the execution of this Second Supplemental Debenture shall in no way prejudice or affect the security granted by it (or the covenants given by it) under the Original Debenture.
- 5.3 References in the Original Debenture to "this Deed" and expressions of similar import shall be deemed to be references to the Original Debenture as supplemented by this Second Supplemental Debenture and to this Second Supplemental Debenture.
- 5.4 This Second Supplemental Debenture is designated as a Loan Document.

6 **Governing law**

This Second Supplemental Debenture and any non-contractual obligations arising out of or in connection with it are governed by English law.

7 **Jurisdiction**

- 7.1 The courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with this Second Supplemental Debenture (including a dispute relating to the existence, validity or termination of this Second Supplemental Debenture or any non-contractual obligation arising out of or in connection with this Second Supplemental Debenture) (a "Dispute").
- 7.2 The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no Party will argue to the contrary.

- 7.3 This Clause 7 is for the benefit of the Bank only. As a result, the Bank shall not be prevented from taking proceedings relating to a Dispute in any other courts with jurisdiction. To the extent allowed by law, the Bank may take concurrent proceedings in any number of jurisdictions.




