Structure, governance and management

Arab Scientific Community Organisation is a company limited by guarantee governed by its Memorandum and Articles of Association dated 20 July 2009 and last amended on 30 October 2017. It is registered as a charity with the Charity Commission.

The charity is structured along the following lines:

- 1) A Board of Trustees comprising the Subscribers to the Memorandum of Association and other persons appointed as directors. A person ceasing to be a director shall cease to be a trustee.
- 2) Management and administration of the charity is under the control of the Director General and the Chairman of the Board of Trustees.

Objectives and activities

The objects for which the charity is established are to advance scientific knowledge for the benefit of the public within the Arab scientific community.

Achievements and performance

ARSCO has continued to focus its activities on the advancement of scientific knowledge for the benefit of the Arab scientific community. Some of more important aspects of our work are as follows:

1. New features to the website:

Add many new features to ARSCO's website with high efficiency and new applications. Improvement and monitoring of the ARSCO website has continued, in structure and content.

2. Agreements

Arab Scientific Community organisation (ARSCO) has signed an agreement with UR Analysis and Process Applied to the Environment (UR17ES32) - Higher Institute of Applied Sciences and Technology, University of Monastir Tunisia, on February 9, 2018.

3. Projects

In collaboration with the University of Hadhramout in Mukalla in Yemen, ARSCO continues supporting "Hadhramout Scientific Agricultural Society" and its activities for improve the agriculture sector in Hadhramaut.

4. Conferences and Workshops

ARSCO participated in one event during this year:

International conference on environmental pollution, risk assessment and remediation 2018, (ICEPRAR2018 in Mahdia (Tunisia) from Wednesday, April 18 to Friday, April 20, 2018.

5. Different kinds of newsletters are published, weekly and on special occasions.

6. The website continues to carry information about meetings and gatherings in various scientific fields providing a valuable source of information for the scientific community.

7. Information and scientometrics studies on recent scientific research in the Arab world are presented regularly on a weekly basis, highlighting the contributors and their countries.


For the year ending 31 December 2018 the charity was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.

Notes to the Financial Statements

Year ended 31 December 2018

1. General information

The charity is a public benefit entity and a private company limited by guarantee, registered in England and Wales and a registered charity in England and Wales. The address of the registered office is 7 Redbridge Lane East, Ilford, Essex IG4 5ET.

2. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

3. Accounting policies

Currency designation

These accounts are presented in US dollars.

Exchange rates at 31 December 2018:

US\$1 = Qarari Riyal 3.64 (31 December 2017 - QR 3.64)

Basis of preparation

The financial statements are prepared in US dollar, which is the functional currency of the entity.

Going concern

There are no material uncertainties about the charity's ability to continue.

Judgements and key sources of estimation uncertainty

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Fund accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for particular future project or commitment.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

3. Accounting policies *(continued)*

Incoming resources

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- legacy income is recognised when receipt is probable and entitlement is established.
- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

4. Limited by guarantee

Members' liability is limited to UK £1 per member.
