The Property and other assets and the Debt are described and defined below and in the Conditions.

### The Main Subject Matter of this Mortgage

#### 1. The Property and other assets



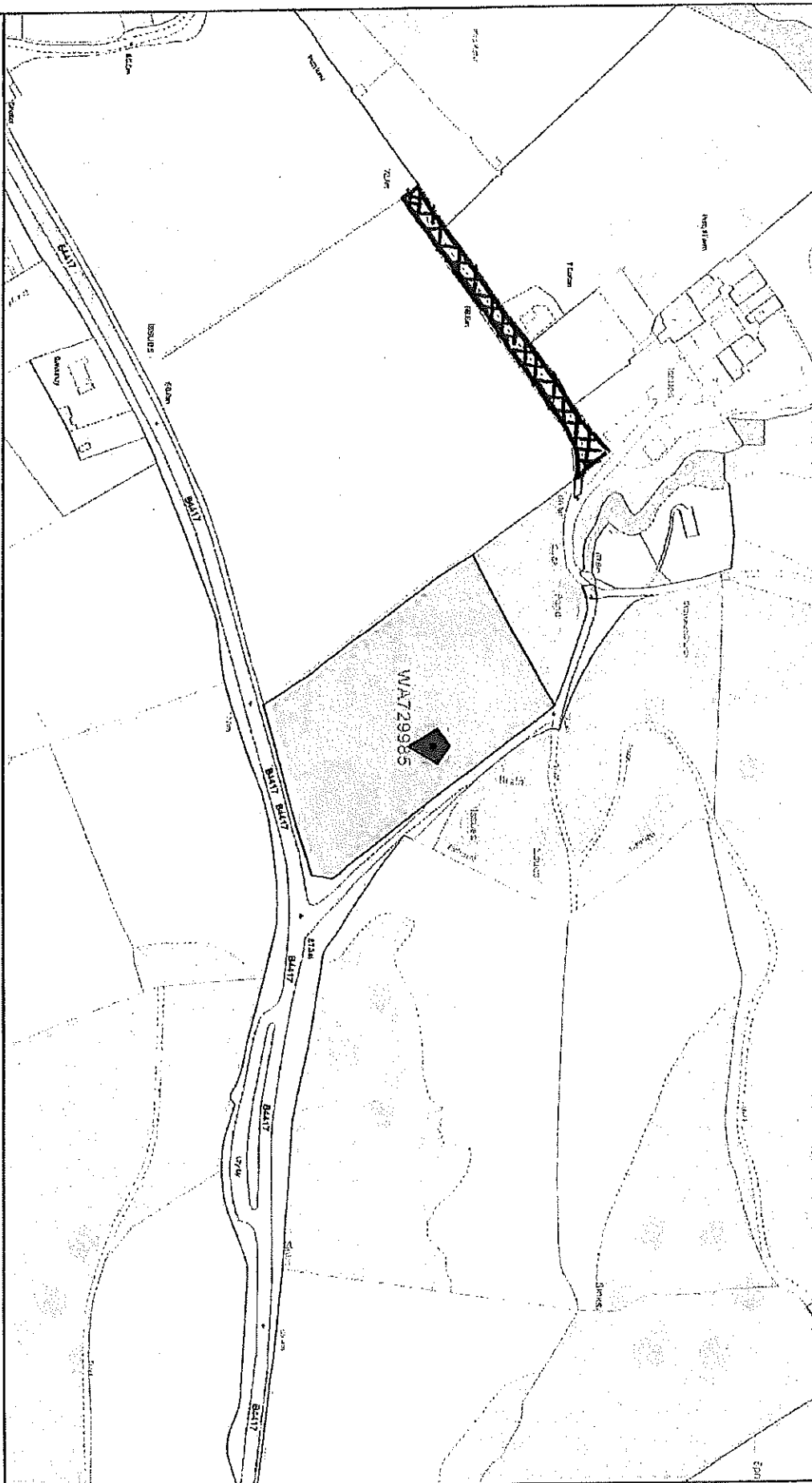
