THE INABILITY FOR ANY REASON OF ANY MEMBER PRESENT IN PERSON OR BY PROXY AT SUCH A VENUE TO VIEW OR HEAR ALL OR ANY OF THE PROCEEDINGS OF THE MEETING OR TO SPEAK AT THE MEETING SHALL NOT IN ANY WAY AFFECT THE VALIDITY OF THE PROCEEDINGS OF THE MEETING.
