
For the year ended 31 December 2015 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.

Notes to the abbreviated financial statements for the year ended 31 December 2015

1. Accounting policies

1.1. Accounting convention

The accounts are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015).

1.2. Turnover

Turnover represents the total invoice value, excluding value added tax, of sales made during the year and derives from the provision of goods falling within the company's ordinary activities.

1.3. Tangible fixed assets and depreciation

Depreciation is provided at rates calculated to write off the cost less residual value of each asset over its expected useful life, as follows:

1.4. Stock

Stock is valued at the lower of cost and net realisable value.

1.5. Foreign currencies

Monetary assets and liabilities denominated in foreign currencies are translated into sterling at the rates of exchange prevailing at the accounting date. Transactions in foreign currencies are recorded at the date of the transactions. All differences are taken to the Profit and Loss account.

1.6. Going concern

These accounts have been prepared on a going concern basis. The director is confident that this method of accounting remains appropriate. As at the year end the company's net liabilities amounted to £124,885 (2014: £132,473) with negative reserves totalling £124,985 (2014: £132,573). During the year, overheads were reduced which together with a strong presence at trade shows enables the director to be optimistic that the company's trade will improve over the coming twelve months. A more direct sales approach to customers has also been adopted. This, together with, the parent company which has given assurances to continue to provide financial support allows the going concern treatment to be applied.
