### **NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2020**

#### **1. COMPANY INFORMATION**

Leonardo Helicopters Pension Scheme (Trustee) Limited is a private company limited by shares and incorporated in England & Wales. The registered office address of the Company is Westland Works, Lysander Road, Yeovil, Somerset, BA20 2YB.

#### **2. ACCOUNTING POLICIES**

The accounts are prepared in Sterling, which is the functional currency of the Company and rounded to the nearest £.

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102) and the requirements of the Companies Act 2006 as applicable to companies subject to the small company regime. The disclosure requirements of section 1A of FRS 102 have been applied other than where additional disclosure is required to show a true and fair view. The financial statements have been prepared under the historical cost convention.

#### **3. INCOME STATEMENT**

The Company has not traded during the current or preceding year and therefore no income statement is presented.

#### **4. INTERCOMPANY ACCOUNT**

The amount owed by the parent company (Leonardo MW Ltd) is in respect of a loan which bears no interest and is repayable on demand.

#### **5. ULTIMATE HOLDING COMPANY**

The immediate parent undertaking is Leonardo MW Ltd, a company incorporated in the United Kingdom and registered in England and Wales. Copies of the financial statements of Leonardo MW Ltd can be obtained from Sigma House, Christopher Martin Road, Basildon, United Kingdom SS14 3EL.

The ultimate parent company and controlling party is Leonardo S.p.a., which is incorporated in Italy, and is the parent undertaking of the smallest and largest group to consolidate these financial statements.
