1 Introduction

- 1 1 Following our appointment as joint administrators of the Companies by ERH Holdings Ltd (Holdings) on 4 November 2014, Alistair Wardell and I are submitting our proposals pursuant to paragraph 49(1) of Schedule B1 to the Insolvency Act 1986 for achieving the objectives of the administration
- 1 2 This report contains the information required by Rule 233 of the Insolvency Rules 1986
- 1 3 In accordance with paragraph 100(2) of Schedule B1 to the Insolvency Act 1986, the functions of the administrators are to be exercised by any or all of them

2 2 The administrations constitute 'main proceedings' under the EC Regulation on Insolvency Proceedings

3 Background to administrators' appointment

- 3 1 The Companies are construction companies based in Yate. Their primary focus is civil transport infrastructure contracts for local authorities and private companies
- 3 2 The Companies form part of the ERH Group, together with ERH Holdings Ltd (Holdings), ERH Communications Ltd (Communications) and Hemtech Ltd (Hemtech)
- 3 3 Grant Thornton UK LLP (the firm) was first consulted by the Directors, on 18 October with a view to the firm giving advice on the Group's financial position
- 3 4 At this stage
- Another firm of advisers had already filed a notice of intention to place the Companies into administration. However, the Directors wished to obtain a second professional opinion, as well as obtain professional advice over the financial condition of the other companies in the Group and brought in the services of our firm
 - The Companies had ceased to trade
 - All employees had been made redundant
 - The Directors had been advised to proceed on a similar basis with all other companies in the ERH Group
 - The Group's bankers had consolidated all individual company bank accounts and withdrawn the Group's overdraft facility
- 3 5 Prior to that consultation, neither we nor the firm had any dealings or involvement with the Companies, their directors or secretary
- 3 6 Having considered all the options, the directors concluded that the best route for the Companies was for them to be placed into administration and allow the other Group Companies (Communications and Holdings) to continue trading
- 3 7 Subsequently, on 4 November 2014 Holdings made the direct appointment of administrators in accordance with paragraph 22 of Schedule B1 to the Insolvency Act 1986

3 8 The objective of an administration is to

- rescue the company as a going concern
- achieve a better result for the company's creditors as a whole than would be likely if the company were wound up
- or, if neither of these is reasonably practicable, to realise property in order to make a distribution to one or more secured or preferential creditors

4 Assets and liabilities

4 1 The Directors have been requested to prepare a statement of affairs of the Companies, but have not yet done so. This is due to a delay in obtaining an accurate balance sheet position as at 4 November 2014, caused by the need of the Group staff to focus on trading the other Group companies

4 2 We summarise below the assets and liabilities of the Companies. A list of the names and addresses of the creditors is attached at Appendix C

4 3 There will be no prescribed part of floating charge assets to be set aside for the benefit of unsecured creditors under Section 176A of the Insolvency Act 1986, as there is no debt due to the secured creditors

Assets

Trade debtors/Work in Progress (WIP) – Construction

4 4 Book debts totalling approximately £694,000 and WIP totalling approximately £98,000 were outstanding at the date of our appointment which we are in the process of collecting. At this stage it is difficult to say how much of this will be recoverable

Trade debtors/WIP – Building

4 5 Book debts totalling approximately £763,000 and WIP totalling approximately £449,000 were outstanding at the date of our appointment which we are in the process of collecting. At this stage it is difficult to say how much of this will be recoverable

Cash at Bank – Construction

4 6 Cash in the bank at the date of appointment was £269,000, held in the Company's bank account

Cash at Bank – Building

4 7 Cash in the bank at the date of appointment was £5,000, held in the Company's bank account

Intercompany position – Construction & Building

4 8 The intercompany position on appointment was as follows

- 4 9 Following the consolidation of the Group bank accounts whilst there was a net positive cash position in the Group (i.e. cash in Group bank accounts with a positive balance was used to pay off the overdrafts of other Group companies), there was a situation where some Group companies have paid off the entire Group's debt. This entitles them to stand in the shoes of the bank and enforce the bank's rights for their own benefit.

- 4 10 This therefore alters the intercompany position as follows

- 4 11 The debt owed by Building to Construction is highly unlikely to be fully realisable in view of the insolvency of Building.
- 4 12 The debts owed by Communications and Holdings to Construction are entirely caused by the bank consolidation process. We are taking legal advice on the recoverability of these debts as we are already aware of counter claims and set offs.
- 4 13 The debts owed by Communications to Building also require further investigation to enable us to demonstrate that the debts are recoverable.
- 4 14 In addition to the above intercompany position, in the weeks leading up to our appointment certain contracts were novated by Construction to Communications for no consideration. Funds believed to be due to Construction which have been or will be received by Communications may total c. £500,000. We are pursuing a recovery of these funds.

Liabilities

Secured creditors – Construction & Building

- 4 15 The Royal Bank of Scotland (RBS) has a fixed and floating charge over the assets of the Companies created on 5 October 2012. At the date of our appointment however, RBS had no lending to the Companies.

Preferential creditors – Construction

- 4 16 The only known preferential creditors are the former employees of Construction who were made redundant on or since 16 October 2014. Preferential claims are subject to a maximum limit set by the insolvency legislation.

4 17 We currently estimate in our consideration of Construction's financial position that preferential creditors are owed approximately £23,000 in respect of arrears of pay and accrued holiday pay due to the employees. It is believed that preferential creditors will be paid in full

Preferential creditors – Building

4 18 There are no known preferential creditors in Building as there are no employees, all staff were employed by other group companies

Unsecured creditors – Construction

4 19 Unsecured non-preferential creditors are estimated at £3,756,030 and based upon present information, it is anticipated that there may be funds available to enable a distribution to be made to unsecured creditors. However, it is not possible to quantify the level of distribution at this stage

Unsecured creditors – Building

4 20 Unsecured non-preferential creditors are estimated at £463,013 and based upon present information, it is anticipated that there may be funds available to enable a distribution to be made to unsecured creditors. However, it is not possible to quantify the level of distribution at this stage

5 Conduct of the administration

Trading and financing of the administration

5 1 All sites were closed and made secure prior to appointment

5 2 The only assets on the Companies' balance sheets are debtors, WIP and cash

5 3 The following were instructed immediately following our appointment

- Craigdam Services Limited (Craigdam) was appointed to assist us in the collection of book debts and WIP
- Temple Bright LLP (Temple Bright) was appointed to provide legal advice on an ad-hoc basis
- ERA Solutions Limited (ERA) was appointed to provide assistance in dealing with any issues arising from the employees of Construction being made redundant

Realisations to date

5 4 The amounts recovered to date from book debts and WIP are £117,421 for Construction and £51,599 for Building

5 5 The amounts recovered in cash from the Companies' bank accounts are £268,618 for Construction and £5,188 for Building

5 6 For more details, please see the information in our receipts and payments account covering the period to 18 December 2014, attached in Appendix B

6 Proposals for achieving the objective of the administration

- 6 1 In this administration, the rescue of the company as a going concern is not an appropriate strategy because the Companies had already ceased to trade before we were appointed as the administrators
- 6 2 The administrators will pursue the objective of achieving a better result for the Companies' creditors as a whole than would be likely if the Companies were wound up, as administration would allow for completion or novation of contracts if considered beneficial to the Companies' creditors
- 6 3 This objective will be achieved by the administrators continuing to work to realise the book debts and WIP of the Companies for as long as they believe it appropriate in attempting a more advantageous realisation of assets
- 6 4 The administrators will continue the Companies' defence to any proceedings brought against the company by, as far as they believe appropriate, bearing in mind the objective of achieving a better result for creditors as a whole than would be likely if the companies were wound up, and mindful of the need to balance the costs of continuing the defence, as against the potential detriment to creditors of abandoning the defence, if it appears that funds may be available to the creditors following the conclusion of the asset realisation process
- 6 5 It is proposed that the administration will end by the Companies going into creditors' voluntary liquidation, or if there are no monies available for unsecured creditors, by the dissolution of the Companies. If the Companies are placed into creditors' voluntary liquidation, it is proposed that the administrators in office at that date will be appointed liquidators, any act in the liquidation to be done by any one or more of the liquidators. However, creditors may nominate a different liquidator or liquidators if nomination to that effect is received before the approval of these proposals

7 Administrators' remuneration and disbursements


- 7 1 The basis of the administrators' remuneration is to be fixed by the creditors. If a creditors' committee is appointed at a meeting convened to consider this statement of proposals or subsequently, then this is a matter for the committee. If no committee is appointed, a resolution of the creditors will be required
- 7 2 Pre-administration costs unpaid at the date of appointment of the administrators may also be approved as above under Rule 2.67A to rank as an expense of the administration. Approval of the statement of proposals does not constitute approval either of the administrators' remuneration or of unpaid pre-administration costs
- 7 3 Pre-administration costs of £23,064 remain unpaid at the date of appointment of the administrators and may also be approved as above under Rule 2.67A to rank as an expense of the administration. The pre-administration costs are in respect of assisting management in the preparation of placing the Companies into administration
- 7 4 Further time costs of c. £69,000 have been written off as they were considered to be not wholly relating to the appointment process

- 7 6 The administrators will request that their remuneration be calculated according to the time properly given by the administrators and their staff in attending to matters arising in the administration Time is charged in 6 minute units
- 7 7 The administrators will charge out of pocket expenses at cost Mileage is charged at the standard rates used from time to time by Grant Thornton UK LLP VAT is added to disbursement charges as necessary
- 7 8 Payments of the administrators' remuneration and disbursements are to be met from funds held in the administration in priority to the claims of creditors
- 7 9 Total time costs to date amount to £81,191 An analysis of time in accordance with Statement of Insolvency Practice 9 is attached at Appendix C for each company

8 Meeting of creditors

- 8 1 Meetings of creditors pursuant to paragraph 51 of Schedule B1 to the Insolvency Act 1986 will be conducted by correspondence in accordance with paragraph 58 of Schedule B1 to the Insolvency Act 1986 Formal notice of the vote by correspondence, form 225B, is enclosed
- 8 2 Any single creditor, or group of creditors, of the company whose debt(s) amount to at least 10% of the total debts of the company may within 5 business days from the date of the sending out of the notice, require the summoning of a meeting of creditors to consider the proposed resolutions Any such request must be made in form 221B, a copy of which may be requested


