1. General information

The company is a private company limited by shares and registered under the Companies Act 2006 in England and Wales. The registered number is 08036134 and the registered office is c/o Grant Thornton Company Secretarial Services, 30 Finsbury Square, London, EC2A 1AG.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The following principal activities have been applied:

2.2 Going concern

In October 2017 the parent company entered into a strategic transaction that resulted in closing the UK business. The company is now dormant. The directors have confirmed that the parent company will provide additional financial support to the company should the company require additional facilities.

2.3 Debtors

Short term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.
