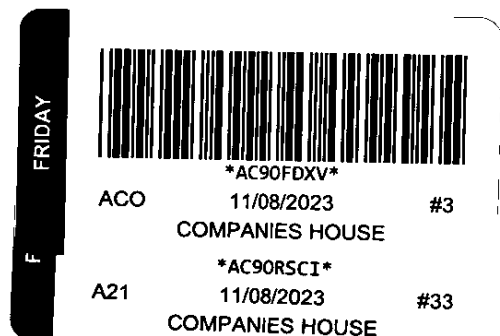

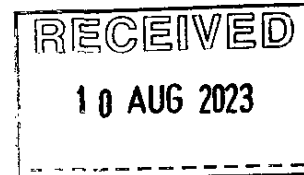

**ORDER**

---

**UPON** the application of Gareth Wyn Roberts and Paul William Ellison for a Block Transfer Order dated 27 April 2023

**AND UPON** hearing Mr Roohani as Counsel for the Applicants

**AND UPON** reading the evidence

**IT IS ORDERED THAT:**

1. Gareth Wyn Roberts (“**Outgoing Office-Holder**”) be removed from office in respect of each of the cases listed in Schedule A (attached to this order) (“**Block Transfer Cases**”) from the date of this Order.

2. Paul William Ellison ("**Replacement Office-Holder A**") be appointed as joint replacement office-holder in respect of each of the block transfer cases listed in Schedule A, Column G, headed "Replacement", where the letters "PE" appear, from the date of this Order.
3. Robert Christopher Keyes ("**Replacement Office-Holder B**") be appointed as joint replacement office-holder in respect of each of the block transfer cases listed in Schedule A, Column G, headed "Replacement", where the letters "RK" appear, from the date of this order.
4. David Ronald Taylor ("**Replacement Office-Holder C**") be appointed as joint replacement office-holder in respect of each of the block transfer cases listed in Schedule A, Column G, headed "Replacement", where the letters "DT" appear, from the date of this order.
5. Replacement Office-Holder A, Replacement Office-Holder B and Replacement Office-Holder C are hereafter referred to collectively as the "**Replacement Office Holders**".
6. The creditors in each of the block transfer cases listed in Schedule A be notified of this order by advertisement published in the London Gazette within 21 days of the date of the Order.
7. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies listed in Schedule A who has an objection to this Order shall have 21 days from the date of the advertisement to apply to Court to set aside or vary the terms of this Order. Such application shall not affect the transfer of the block transfer cases listed in Schedule A until further or other Order by the court.
8. The Replacement Office Holders shall give notice to the Secretary of State for Business, Energy and Industrial Strategy and to the Registrar of Companies in respect of the insolvency proceedings listed in Schedule A of the terms of this Order as soon as reasonably practicable.
9. Nothing in this Order shall release the Outgoing Office-Holder from any obligation to give and file notices in respect of the office-holder's removal under this Order in respect of the block transfer cases.
10. The costs of this application in the amount of £10,577.50 shall be paid as an expense and shall be apportioned equally between each of the block transfer cases (save for those indicated by an asterisk in Part K of Schedule A) so that the estate of each such block transfer case shall bear an equal proportion of the costs.
