The directors do not recommend the payment of a dividend (2019: nil).

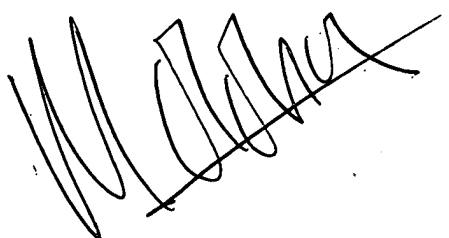
