- 1 Realisation of assets
 - 1.1 Cash at Bank – Textanywhere Limited

The declaration of solvency detailed cash at bank of £1. Following discussions with the members and their tax advisors, RSM UK Tax and Accounting Limited, it was agreed due to the quantum, this asset be written off rather than distributed in specie.
 - 1.2 Intercompany debtors

Further to discussions with the members and their tax advisors, it was agreed all inter-company transactions for the Companies be written off, rather than being distributed in specie.
- 2 Payments to creditors

Trade creditors

Notices to creditors to prove were advertised in the London Gazette requesting proof of claims to be submitted by 7 February 2020.

No trade creditors were identified and no payments were made.

Textanywhere Limited and Textworld Limited - Intercompany creditor

The declaration of solvency of Textanywhere Limited detailed an investment in its subsidiary company, Textworld Limited, as an asset of £1,000. This declaration of solvency also detailed an unsecured intercompany creditor of £1,000 owing to Textworld Limited. .Similarly, these transactions were also reflected on the declaration of solvency of Textworld Limited.

Further to discussions with RSM UK Tax and Accounting Limited, it was agreed that the unsecured creditors would net off against the asset realisations and therefore no formal creditor distribution was undertaken


 - 5.1 Authority for remuneration and disbursements


