

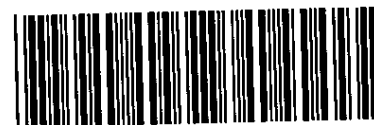



ORDER

---

UPON the application of Alan Brian Coleman ("Applicant") dated      for a Block Transfer Order in  
relation to the appointments of Julie Webster ("Respondent")

AND UPON READING the witness statements of the Applicant dated 25/10/17 in support of the  
Application and the Respondent dated 25/10/17 confirming that she has no objection to the  
Application

1. The cases listed in Schedule attached to this Order, in so far as they are currently proceedings  
in a County Court, other District Registries or the Royal Courts of Justice, those proceedings

be transferred to the High Court, Manchester District Registry, solely for the purpose of hearing the application for the Orders sought below.

2. The High Court shall have jurisdiction over each of the insolvency matters in the attached Schedule which have not yet been issued at Court or have not yet been allocated a Court reference.
3. In respect of each estate in bankruptcy referred to in Part 1 of the attached Schedule and pursuant to Sections 298 (1) and 303 (2) of the Insolvency Act 1986 (“Act”) and r.12.36(2) of the Insolvency (England and Wales) Rules 1986 (“Rules”):
  - a. the Respondent be removed from the office of trustee in bankruptcy of the relevant individual; and
  - b. the Applicant be appointed as trustee in bankruptcy.
4. In respect of each administration referred to in Part 2 of the attached Schedule, and pursuant to paragraph 88 of Schedule B1 to the Act and rule 12.36(2) of the Rules the Respondent be removed from the office of Administrator of the relevant company with immediate effect.
5. In respect of each compulsory liquidation referred to in Part 2 of the attached Schedules and pursuant to Section 172 (2) of the Act and r.12.36(2) of the Rules the Respondent be removed from the office of liquidator of the relevant company subject to a compulsory winding up Order.
6. In respect of each creditors’ voluntary liquidation referred to in Part 2 of the attached Schedule and pursuant to Section 108 of the Act the Respondent be removed from the office of liquidator of the relevant company with immediate effect.
7. In respect of each members’ voluntary liquidation referred to in Part 2 of the attached Schedule and pursuant to Section 108 of the Act the Respondent be removed from the office of liquidator of the relevant company with immediate effect.
8. In respect of each individual voluntary arrangement referred to in Part 2 of the attached Schedule and pursuant to Section 263 (5) of the Act and r.12.36(2) of the Rules the Respondent be removed from the office of supervisor of the individual voluntary arrangement of the relevant individual.
9. The Applicant shall give notice of this Order to the creditors, or, in the case of any members’ voluntary liquidation, any member, in each of the insolvency proceedings set out in the Schedule hereto at the first reasonable opportunity to do so and in any event within 28 days of the date of this Order, by placing a block advertisement in the London Gazette.

10. There be liberty to each creditor, or, in the case of any members' voluntary liquidation, any member, to apply to vary or discharge this Order insofar as it relates to the estate of which they are a creditor or member within 28 days of the date of advertisement in accordance with paragraph 9. Such application shall not affect the transfer of the block transfer cases until further or other order by the court.

11. The Applicant shall file a copy of this order with each of the courts listed in the Schedule.

12. The Respondent shall

- a. be at liberty to apply to the Secretary of State for her release from her position as
  - i. Trustee in bankruptcy, pursuant to s.299(b)(ii) of the Act;
  - ii. Voluntary liquidator, pursuant to s.173(2)(b)(ii) of the Act; and
  - iii. Liquidator of a company being wound up by the Court, pursuant to 174(4)(b)(ii) of the Act; and
- b. receive her release as administrator pursuant to Paragraph 98(2)(c) of Schedule B1 to the Act

28 days after the relevant notice referred to in paragraph 9 above has been advertised save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 10 of this order for the specific case subject to that application.

13. Following the Orders made in paragraphs 1 to 8 above, the proceedings referred to in the Schedule be transferred back to the respective County Courts, District Registries and Royal Courts of Justice, as the case may be.

14. Pursuant to r.12.38 of the Rules, the costs of this application be apportioned equally and payable as an expense of the insolvency proceedings to which the application relates save that where such apportioned costs would exceed 10% of the value of the realised assets in such proceedings those costs shall be apportioned equally and payable as an expense of the remaining insolvency proceedings.
