SPECIAL RESOLUTION

THAT:

- a) the share capital of the Company as at the date of this resolution be reduced from £35,000.01 to £0.10 and such reduction shall be effected by cancelling and extinguishing 3,499,991 ordinary shares of £0.01 each in the capital of the Company;
- b) the amount of £3,360,000.00 standing to the credit of the share premium account of the Company at the date of the passing of this resolution be and is hereby cancelled; and
- c) the reduction of the share capital and the cancellation of the amount standing to the credit of the share premium account of the Company shall be effected by applying the sums arising therefrom to the Company's distributable reserves.

ORDINARY RESOLUTION

THAT:

a cash distribution of £2,590,259.22 be declared, and that such distribution be satisfied by the transfer by the Company to its sole shareholder, TM Trading Limited, funds on such date as the directors may determine.

- (7) In the case of joint holders of shares, only the vote of the senior holder who votes will be counted by the Company. Seniority is determined by the order in which the names of the joint holders appear in the register of members.
