**IT IS ORDERED** that following in accordance with Regulation 16 (Court approval of cross-border merger) of the Companies (Cross-Border Mergers) Regulations 2007 (**Regulations**) for the purposes of Article 128 of Directive EU 2017/1132 (Scrutiny of the legality of the cross-border merger) the completion of the merger between the Claimants is hereby approved

**AND IT IS ORDERED THAT** the merger, including all of the consequences of the merger as set out in Regulation 17 (Consequences of a cross-border merger) of the Regulations, will take effect on 22 April 2019 at 12.01am (UK time), provided that (i) the Regulations are in force on that date; and (ii) the consequences of the merger as set out in Regulation 17 are capable of recognised on that date under EU/Dutch law

**AND IT IS ORDERED THAT** the Claimants have liberty to restore the matter before Mr Justice Marcus Smith
