

UPON THE APPLICATION of the Applicant AND UPON READING the evidence IT IS ORDERED THAT:

- 1. The cases listed in the schedules attached to this Order which are proceeding in the County Court are transferred to the High Court (Royal Court of Justice) solely for the purposes of this Order and thereafter are transferred back to the original court.
